



The relative strengths and weaknesses of Dreßler Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dreßler Bau GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 125% points. The greatest weakness of Dreßler Bau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 505% points.

The company's Economic Capital Ratio, given in the ranking table, is 125%, being 32% points below the market average of 156%.
