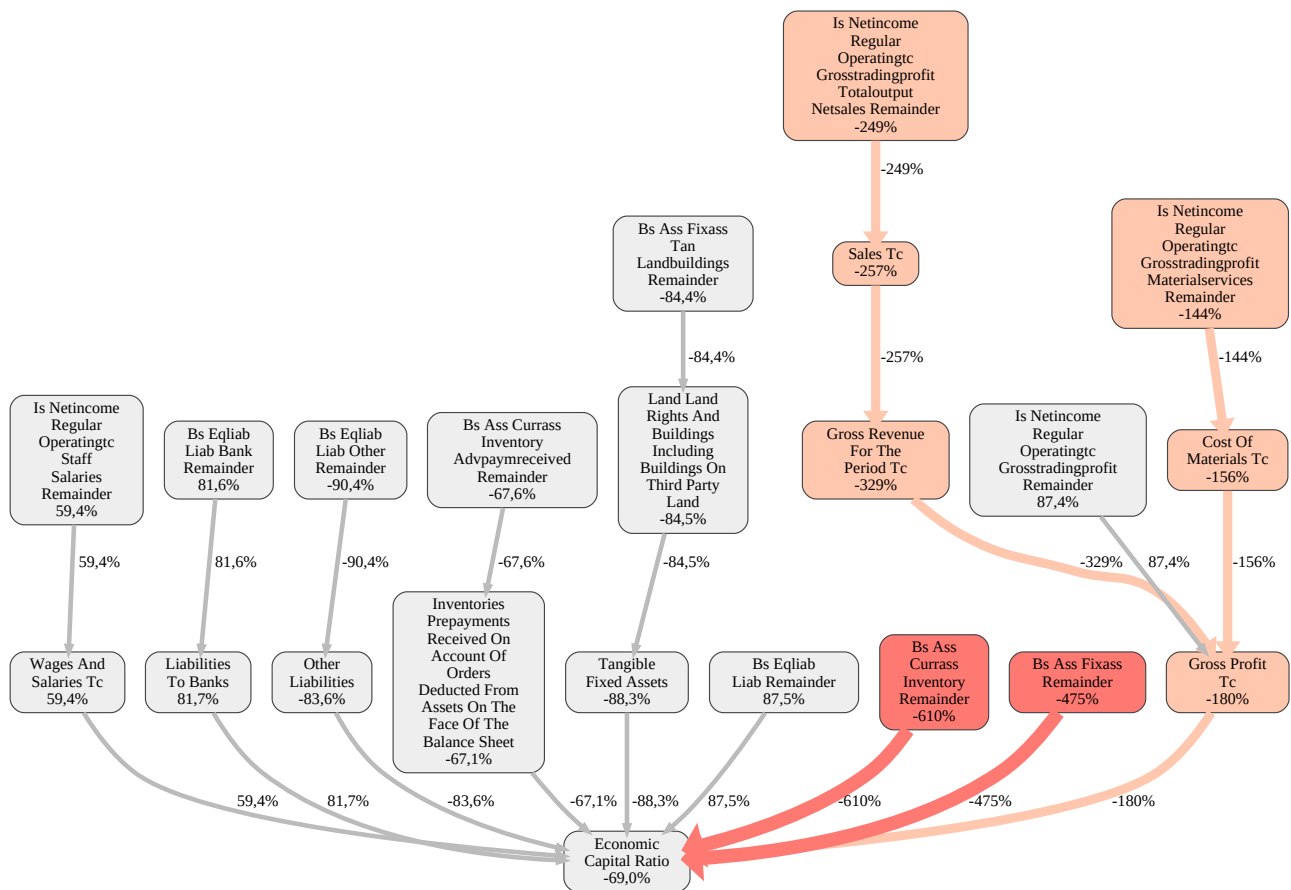




The relative strengths and weaknesses of Kögel Bau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kögel Bau GmbH Co KG compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 87% points. The greatest weakness of Kögel Bau GmbH Co KG is the variable Bs Ass Currass Inventory Remainder, reducing the Economic Capital Ratio by 610% points.

The company's Economic Capital Ratio, given in the ranking table, is 87%, being 69% points below the market average of 156%.
