

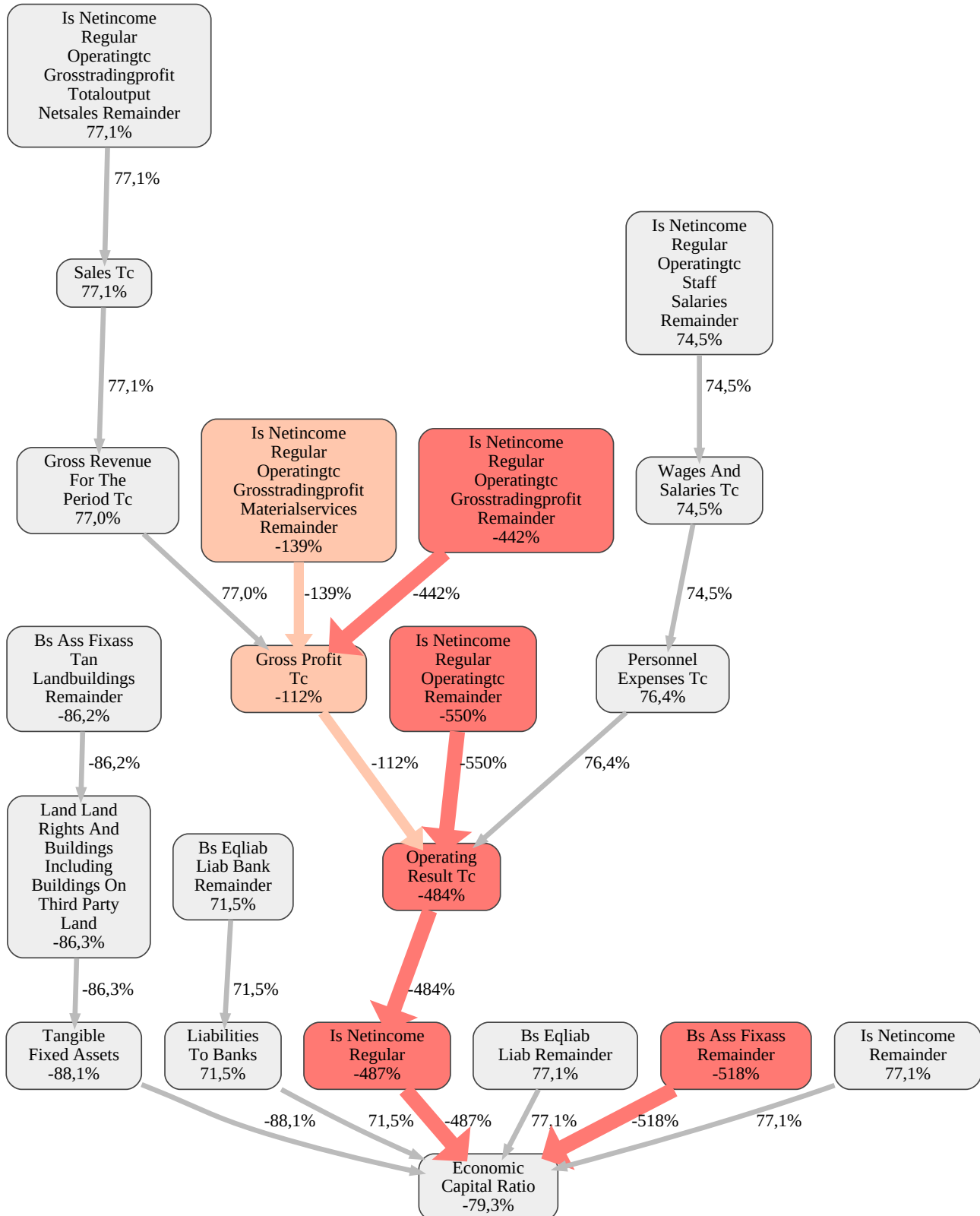

The relative strengths and weaknesses of Hans Graf Bauunternehmung GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hans Graf Bauunternehmung GmbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 77% points. The greatest weakness of Hans Graf Bauunternehmung GmbH Co KG is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 550% points.

The company's Economic Capital Ratio, given in the ranking table, is 77%, being 79% points below the market average of 156%.
