



The relative strengths and weaknesses of Sax Klee GmbH Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Sax Klee GmbH Bauunternehmung compared to the market average is the variable Bs Eqlib Liab Remainder, increasing the Economic Capital Ratio by 94% points. The greatest weakness of Sax Klee GmbH Bauunternehmung is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 448% points.

The company's Economic Capital Ratio, given in the ranking table, is 94%, being 62% points below the market average of 156%.
