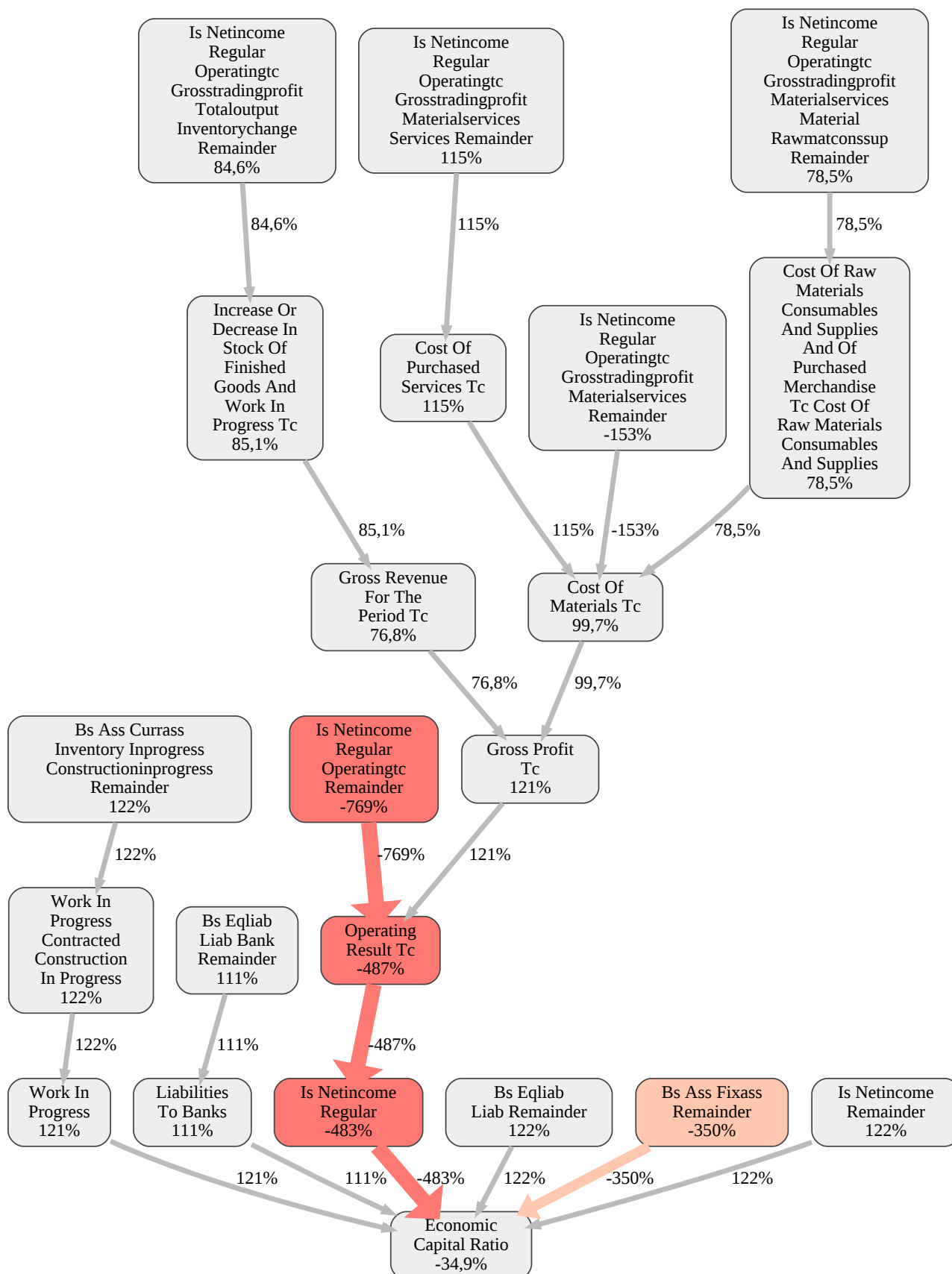




The relative strengths and weaknesses of Glass GmbH Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Glass GmbH Bauunternehmung compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 122% points. The greatest weakness of Glass GmbH Bauunternehmung is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 769% points.

The company's Economic Capital Ratio, given in the ranking table, is 122%, being 35% points below the market average of 156%.
