The greatest strength of Xaver Lutzenberger GmbH Co KG Bauunternehmung compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 106% points. The greatest weakness of Xaver Lutzenberger GmbH Co KG Bauunternehmung is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 541% points.

The company's Economic Capital Ratio, given in the ranking table, is 106%, being 50% points below the market average of 156%.
