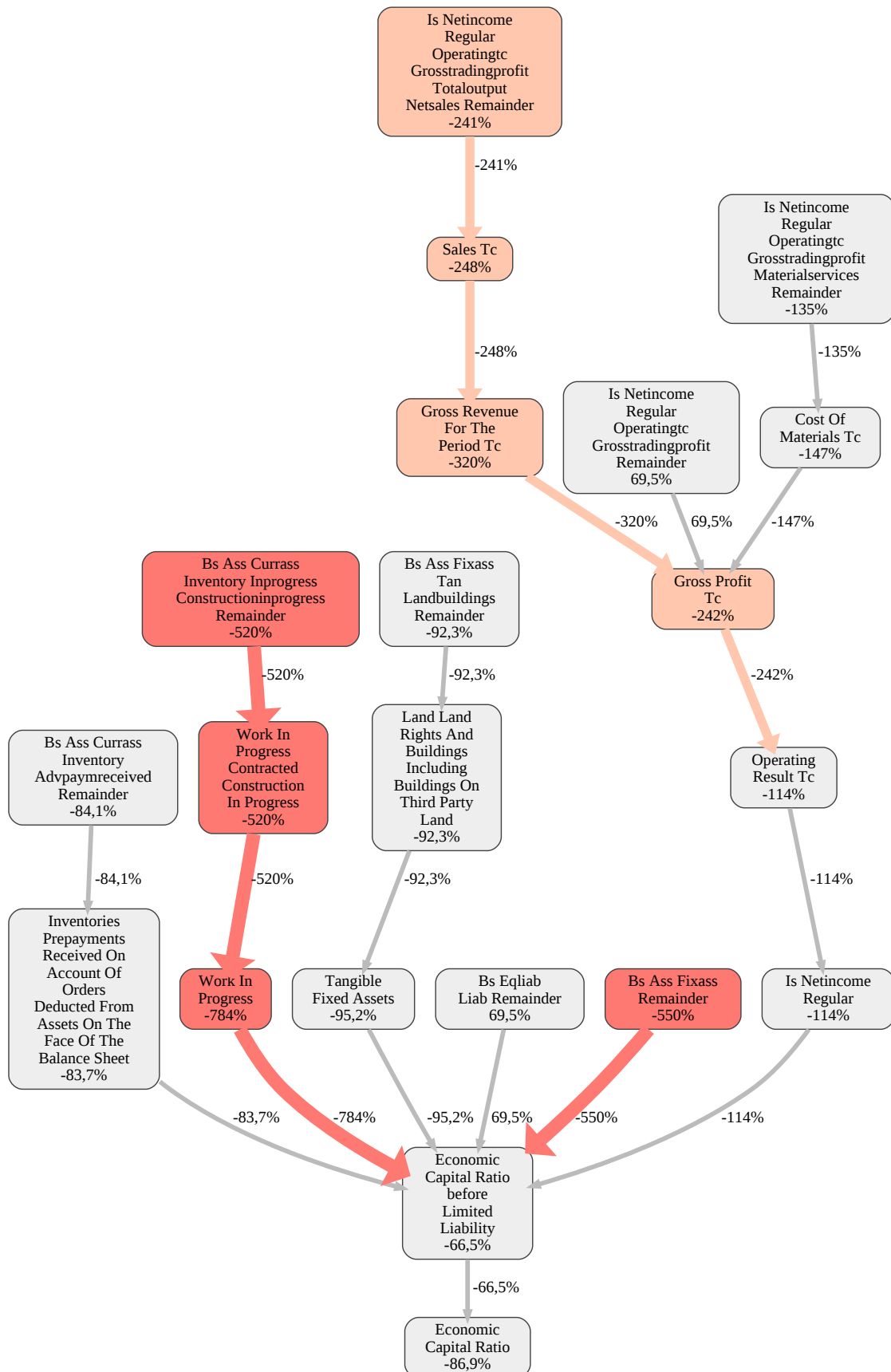

The greatest strength of Bauunternehmung Hofschröder GmbH Co KG compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 70% points. The greatest weakness of Bauunternehmung Hofschröder GmbH Co KG is the variable Work In Progress, reducing the Economic Capital Ratio by 784% points.

The company's Economic Capital Ratio, given in the ranking table, is 70%, being 87% points below the market average of 156%.
