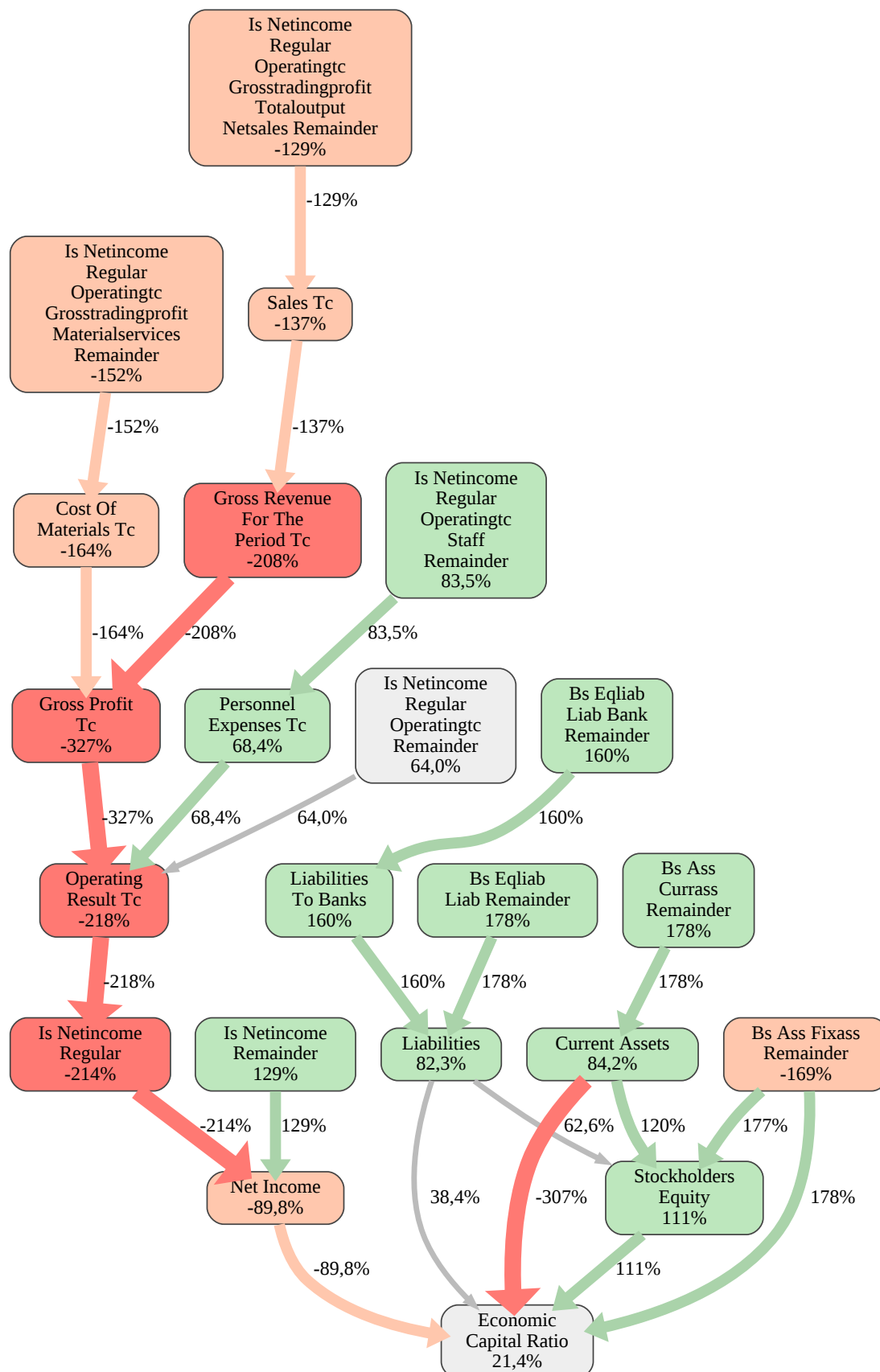




The relative strengths and weaknesses of Otto Maier GmbH Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Otto Maier GmbH Bauunternehmung compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 178% points. The greatest weakness of Otto Maier GmbH Bauunternehmung is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 327% points.

The company's Economic Capital Ratio, given in the ranking table, is 178%, being 21% points above the market average of 156%.
