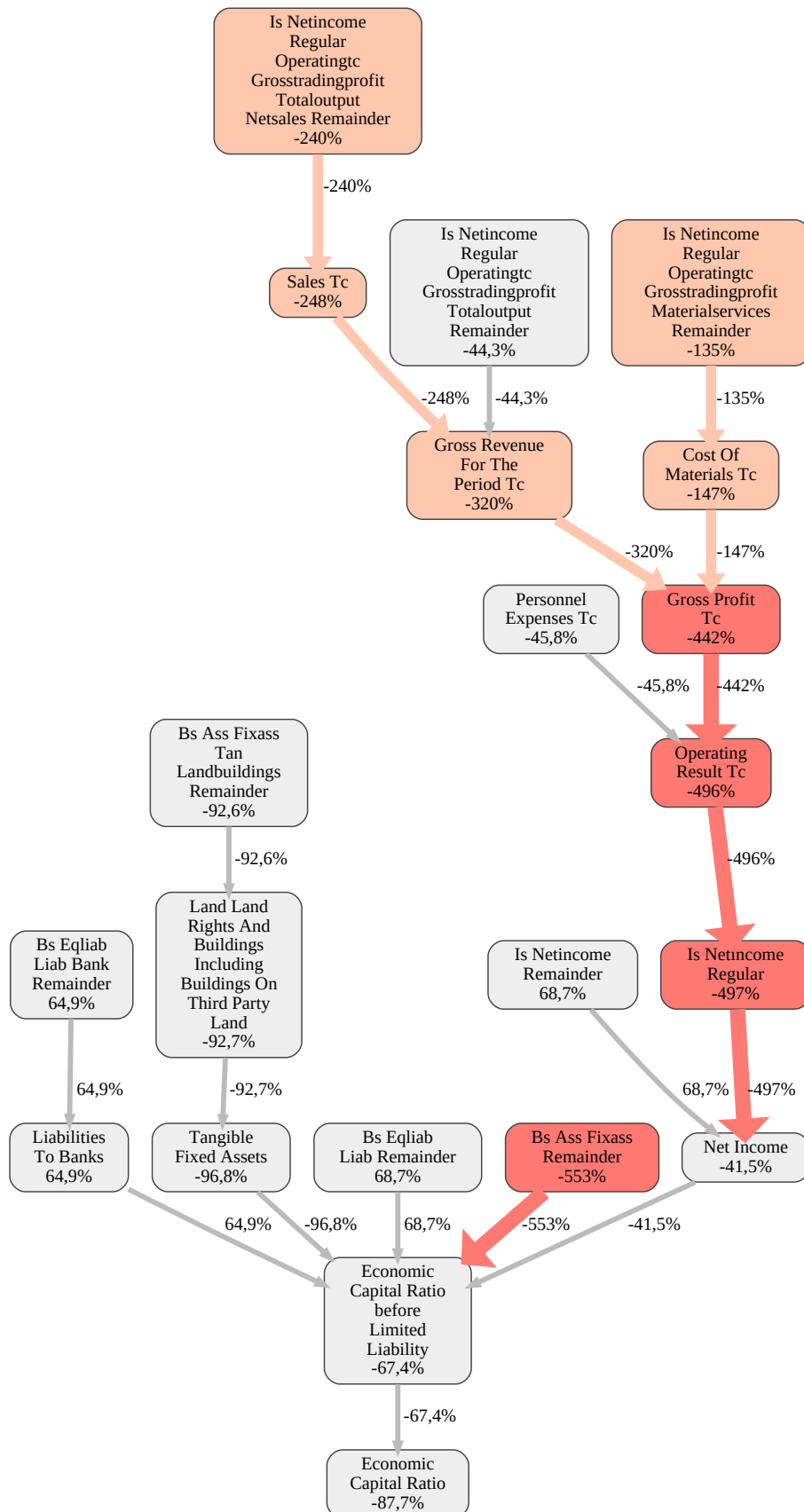




The relative strengths and weaknesses of Meier Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Meier Bau GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 69% points. The greatest weakness of Meier Bau GmbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 553% points.

The company's Economic Capital Ratio, given in the ranking table, is 69%, being 88% points below the market average of 156%.
