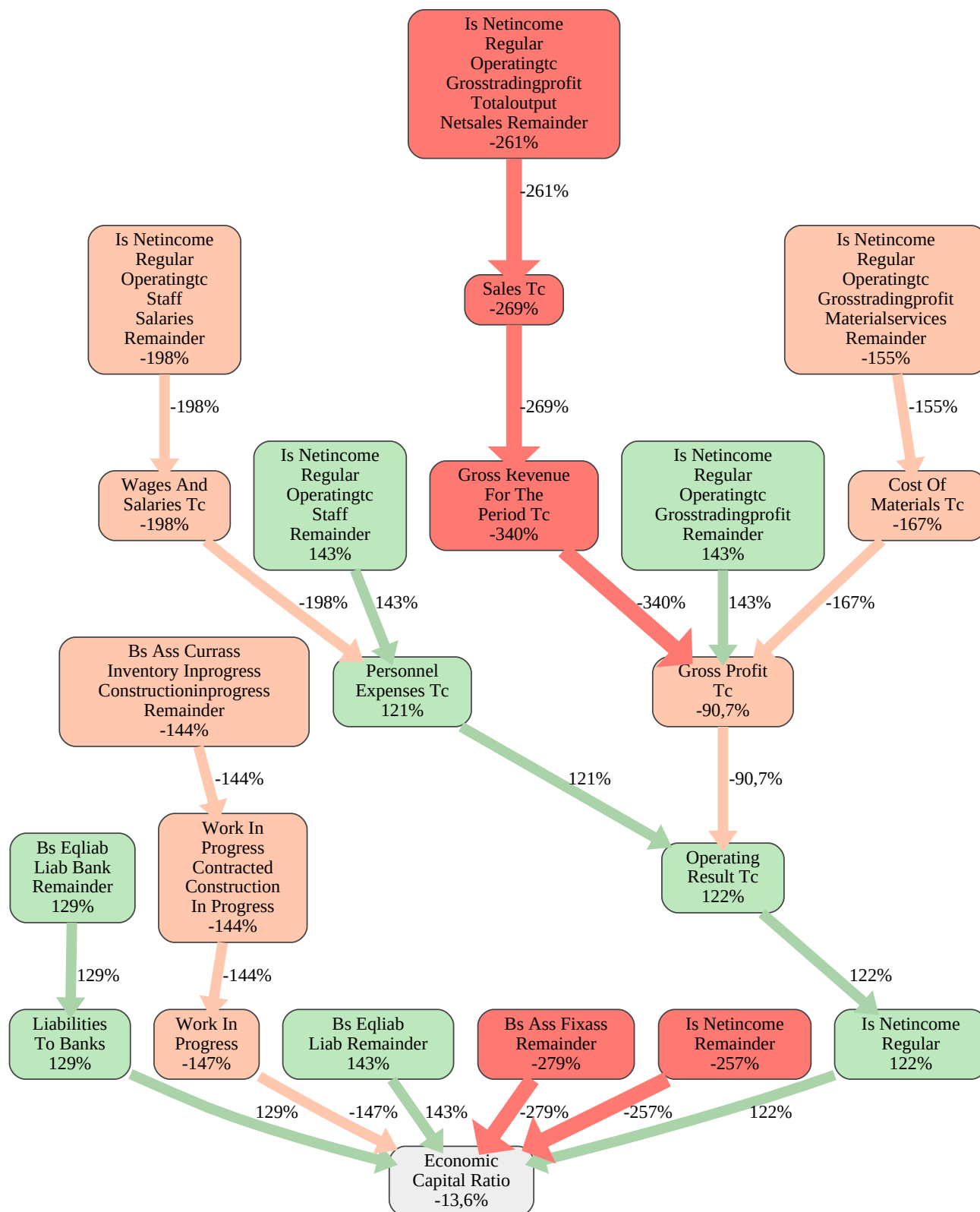




The relative strengths and weaknesses of Angermüller Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Angermüller Bau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Staff Remainder, increasing the Economic Capital Ratio by 143% points. The greatest weakness of Angermüller Bau GmbH is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 340% points.

The company's Economic Capital Ratio, given in the ranking table, is 143%, being 14% points below the market average of 156%.
