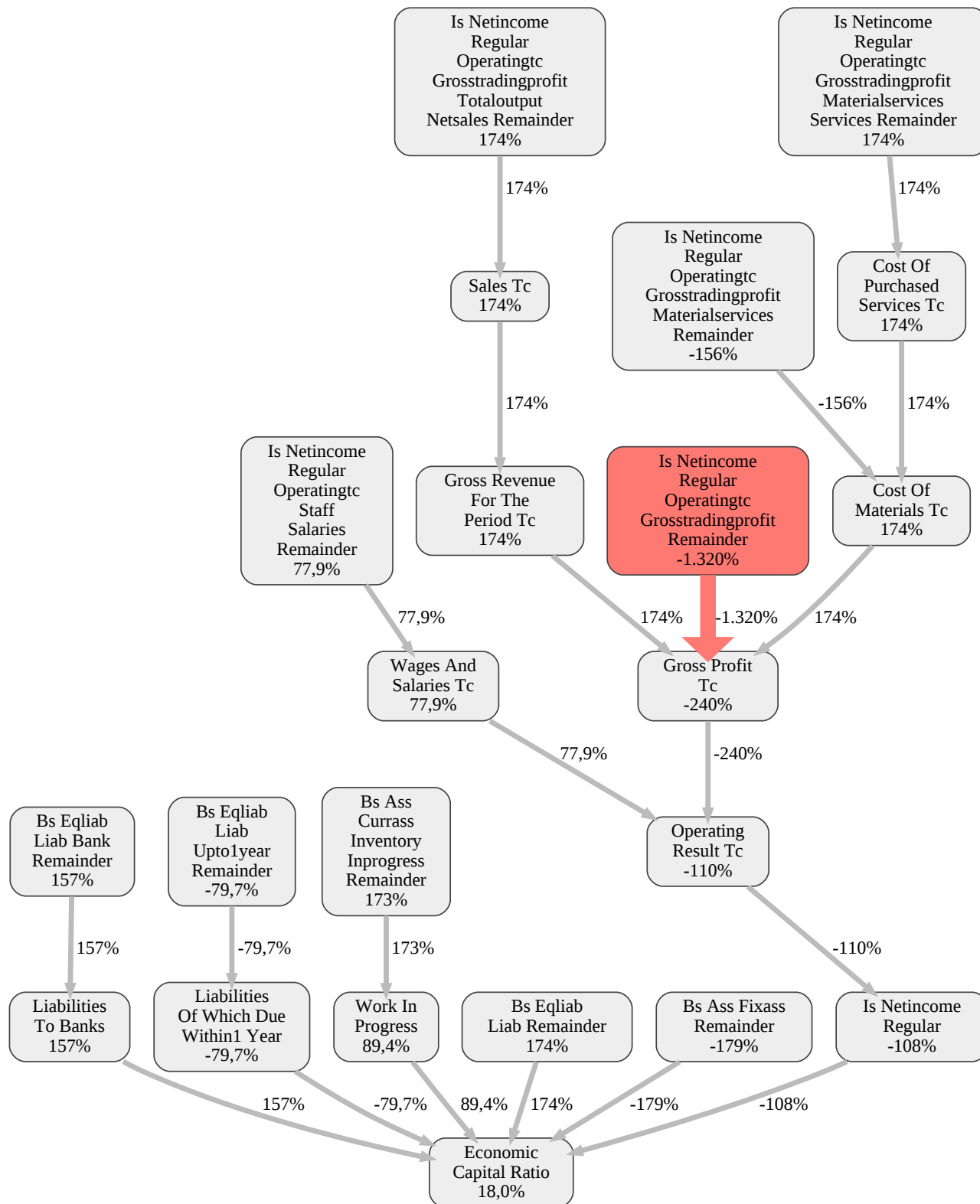




The relative strengths and weaknesses of Schmeing Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schmeing Bau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Remainder, increasing the Economic Capital Ratio by 174% points. The greatest weakness of Schmeing Bau GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 1.320% points.

The company's Economic Capital Ratio, given in the ranking table, is 174%, being 18% points above the market average of 156%.
