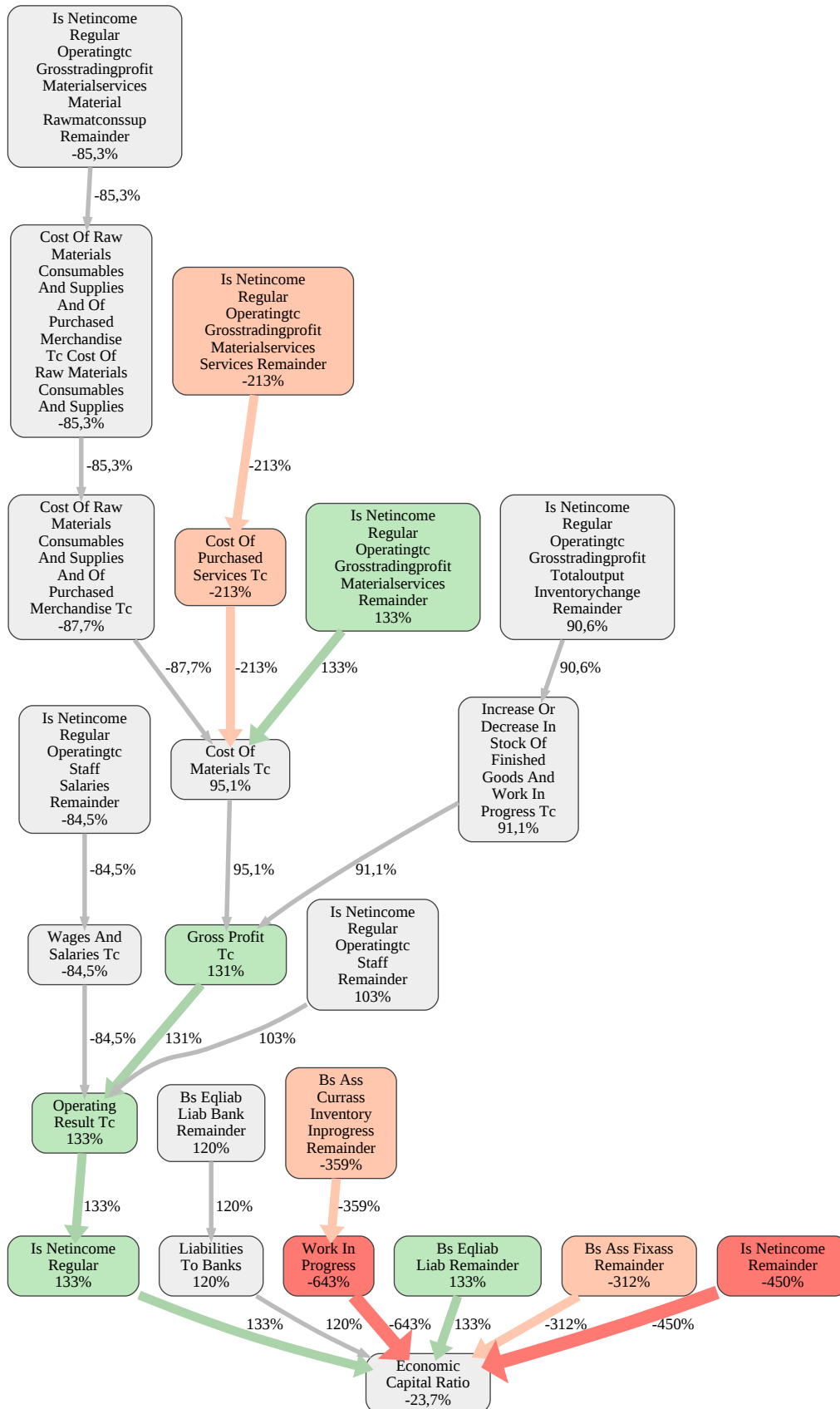




The relative strengths and weaknesses of Hentschke Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hentschke Bau GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 133% points. The greatest weakness of Hentschke Bau GmbH is the variable Work In Progress, reducing the Economic Capital Ratio by 643% points.

The company's Economic Capital Ratio, given in the ranking table, is 133%, being 24% points below the market average of 156%.
