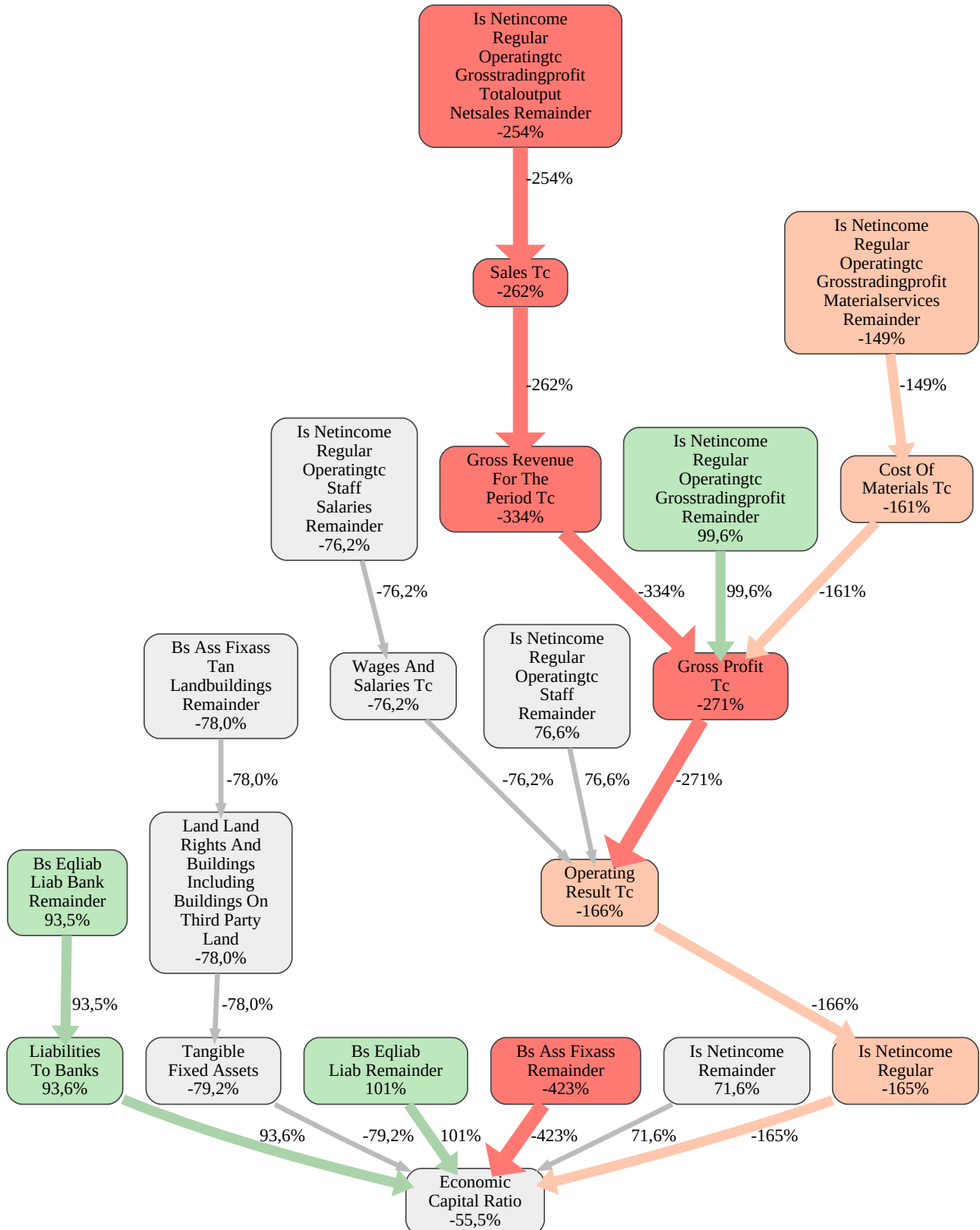

The greatest strength of Jökel Bau GmbH Co KG compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 101% points. The greatest weakness of Jökel Bau GmbH Co KG is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 423% points.

The company's Economic Capital Ratio, given in the ranking table, is 101%, being 55% points below the market average of 156%.
