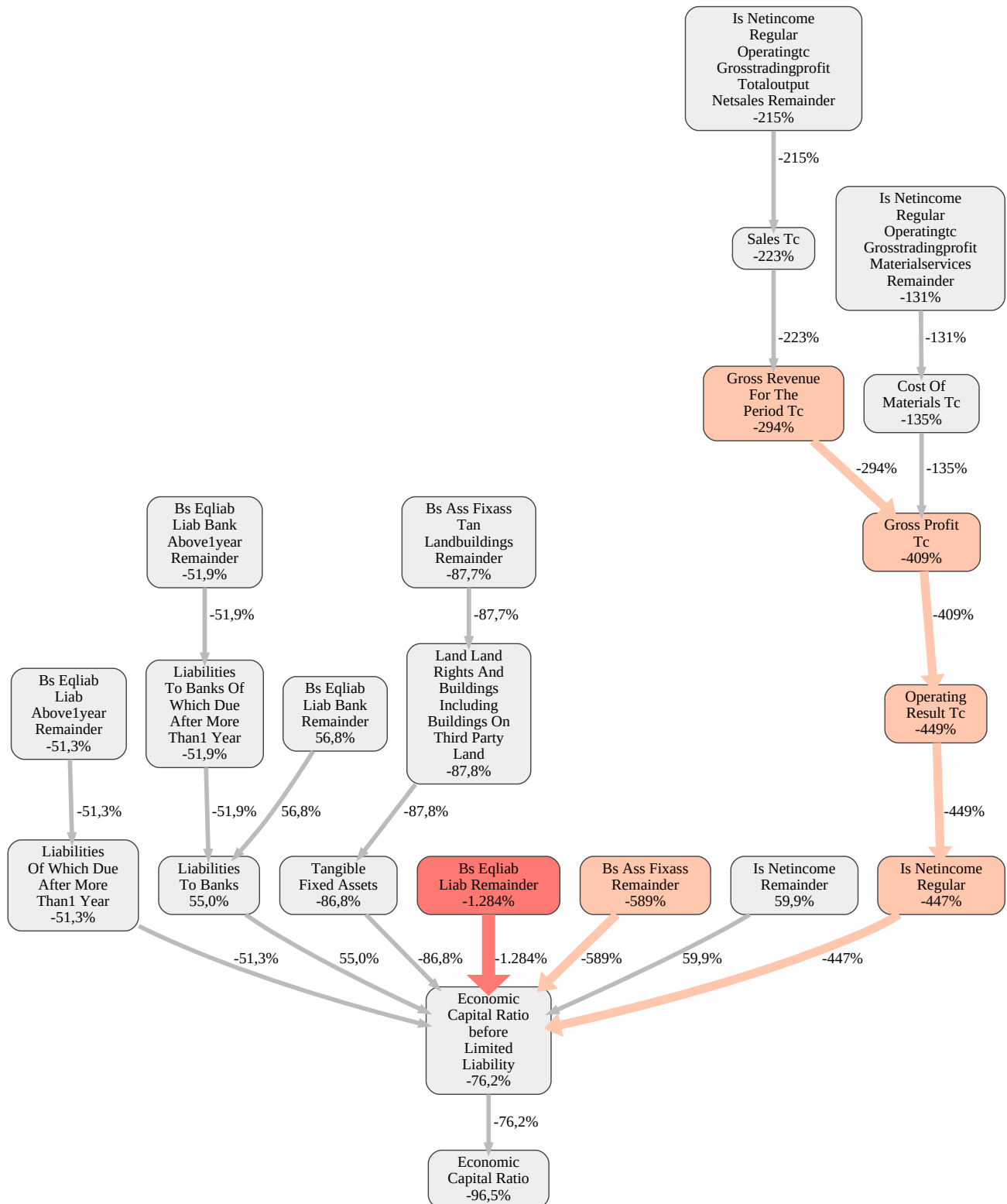

The greatest strength of Hanova Gewerbe GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 60% points. The greatest weakness of Hanova Gewerbe GmbH is the variable Bs Eqliab Liab Remainder, reducing the Economic Capital Ratio by 1.284% points.

The company's Economic Capital Ratio, given in the ranking table, is 60%, being 97% points below the market average of 156%.
