

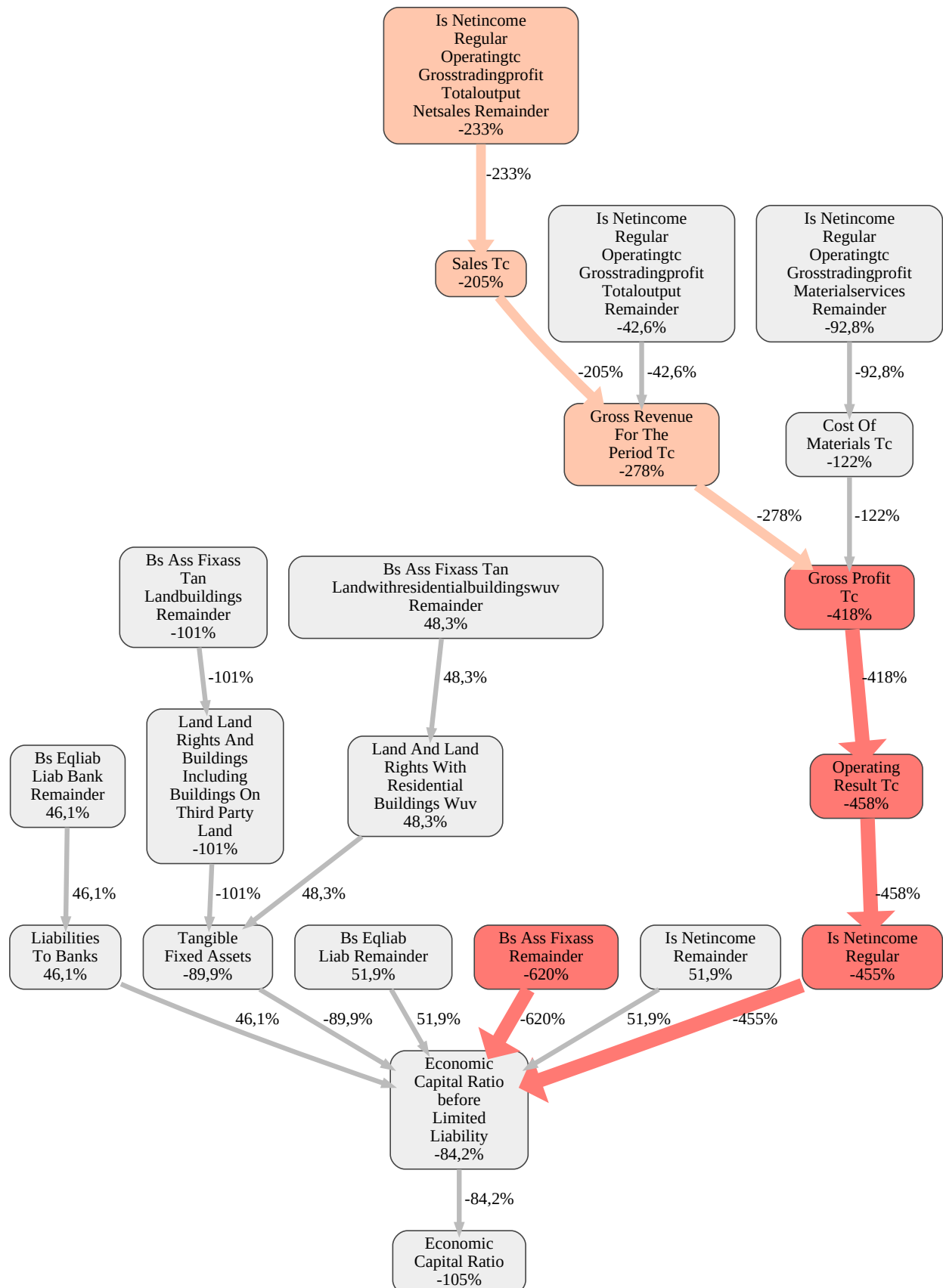

The relative strengths and weaknesses of Goslarer Wohnstättengesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Goslarer Wohnstättengesellschaft mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 52% points. The greatest weakness of Goslarer Wohnstättengesellschaft mbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 620% points.

The company's Economic Capital Ratio, given in the ranking table, is 52%, being 105% points below the market average of 156%.
