The greatest strength of Gesobau AG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 70% points. The greatest weakness of Gesobau AG is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 547% points.

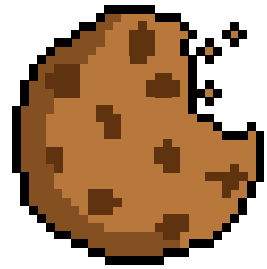
The company's Economic Capital Ratio, given in the ranking table, is 70%, being 86% points below the market average of 156%.
