The company's Economic Capital Ratio, given in the ranking table, is 36%, being 120% points below the market average of 156%.

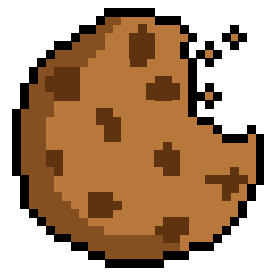
