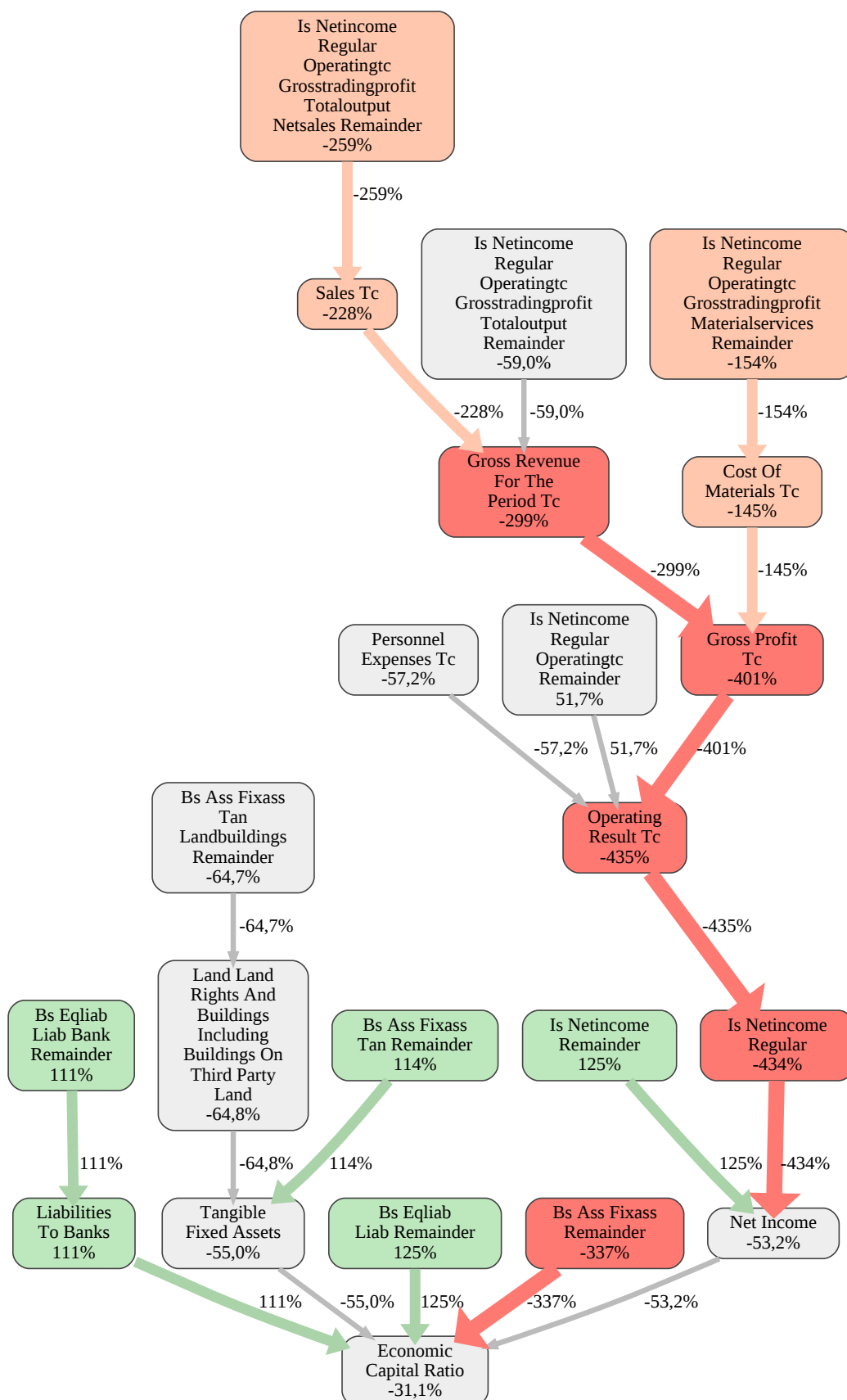




The relative strengths and weaknesses of Gebäude und Grundstücksgesellschaft Zwickau mbH GGZ are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gebäude und Grundstücksgesellschaft Zwickau mbH GGZ compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 125% points. The greatest weakness of Gebäude und Grundstücksgesellschaft Zwickau mbH GGZ is the variable Operating Result Tc, reducing the Economic Capital Ratio by 435% points.

The company's Economic Capital Ratio, given in the ranking table, is 125%, being 31% points below the market average of 156%.
