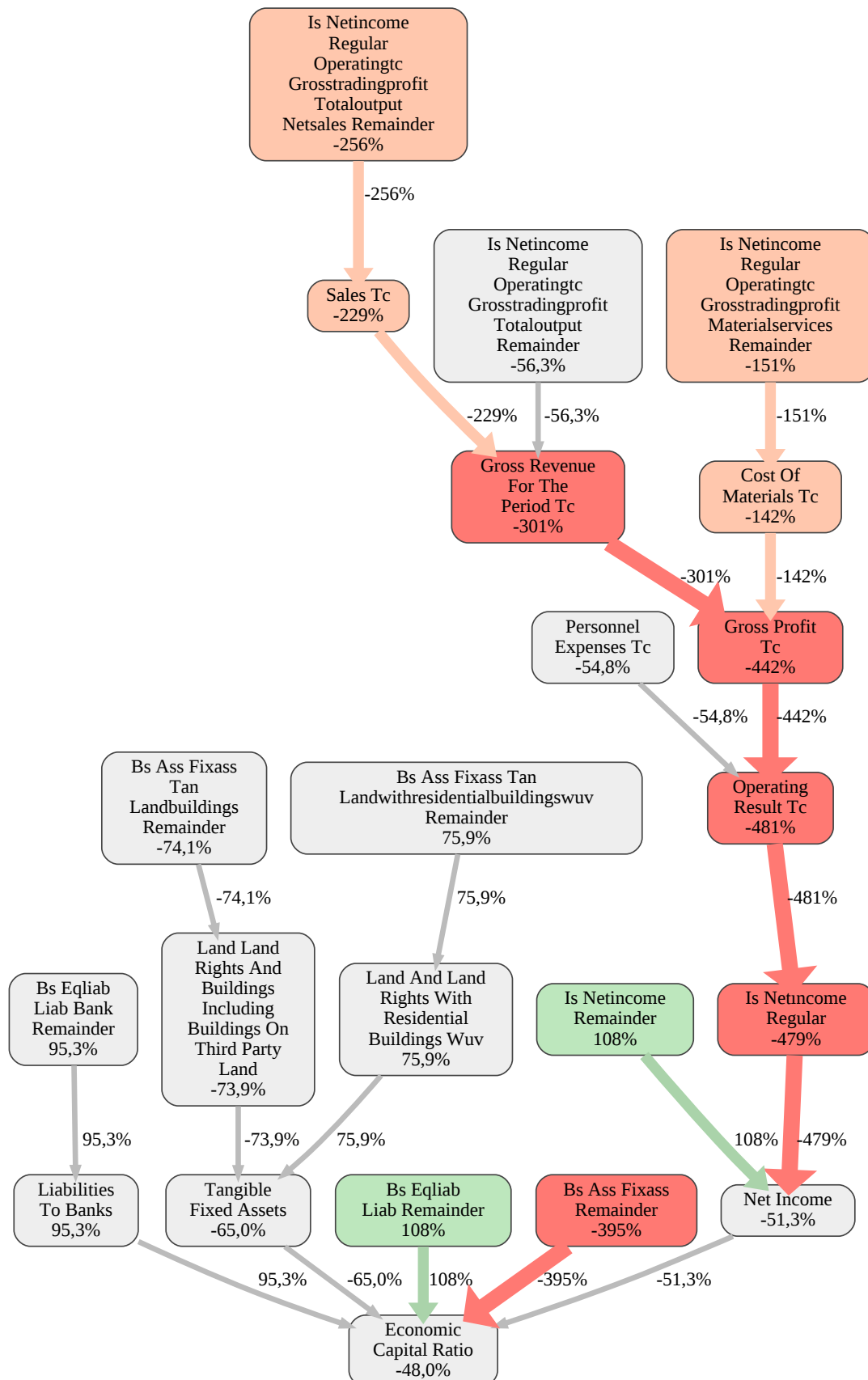




The relative strengths and weaknesses of Wohnungs und Baugesellschaft mbH Bernau are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungs und Baugesellschaft mbH Bernau compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 108% points. The greatest weakness of Wohnungs und Baugesellschaft mbH Bernau is the variable Operating Result Tc, reducing the Economic Capital Ratio by 481% points.

The company's Economic Capital Ratio, given in the ranking table, is 108%, being 48% points below the market average of 156%.
