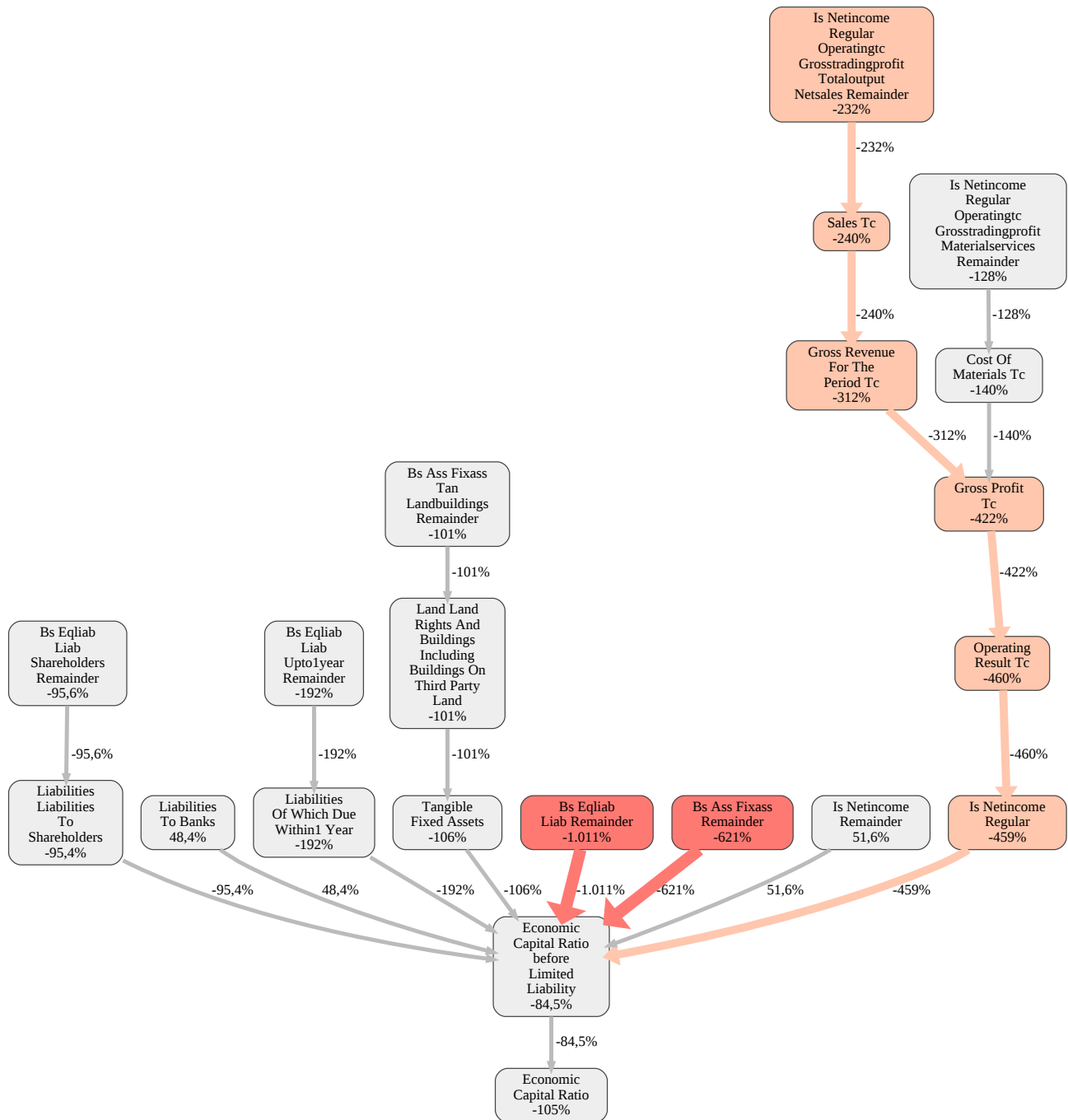




The relative strengths and weaknesses of GVV Städtische Wohnbaugesellschaft Singen mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GVV Städtische Wohnbaugesellschaft Singen mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 52% points. The greatest weakness of GVV Städtische Wohnbaugesellschaft Singen mbH is the variable Bs Eqliab Liab Remainder, reducing the Economic Capital Ratio by 1.011% points.

The company's Economic Capital Ratio, given in the ranking table, is 52%, being 105% points below the market average of 156%.
