



The relative strengths and weaknesses of Wohnungsbau und Verwaltungsgesellschaft Saalfeld Saale mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau und Verwaltungsgesellschaft Saalfeld Saale mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 82% points. The greatest weakness of Wohnungsbau und Verwaltungsgesellschaft Saalfeld Saale mbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 499% points.

The company's Economic Capital Ratio, given in the ranking table, is 82%, being 75% points below the market average of 156%.
