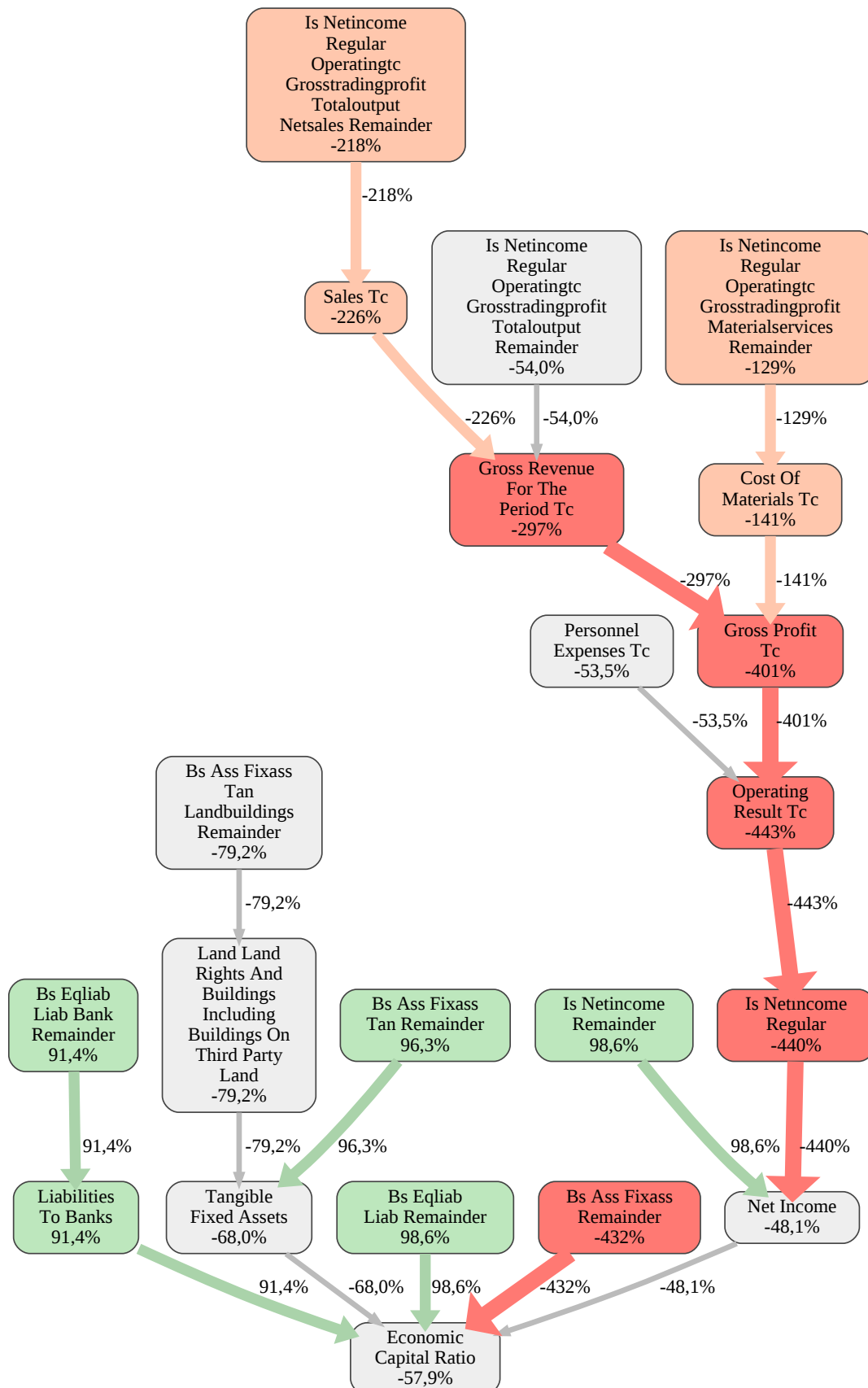




The relative strengths and weaknesses of Wiwog Wittenberger Wohnungsbaugesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wiwog Wittenberger Wohnungsbaugesellschaft mbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 99% points. The greatest weakness of Wiwog Wittenberger Wohnungsbaugesellschaft mbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 443% points.

The company's Economic Capital Ratio, given in the ranking table, is 99%, being 58% points below the market average of 156%.
