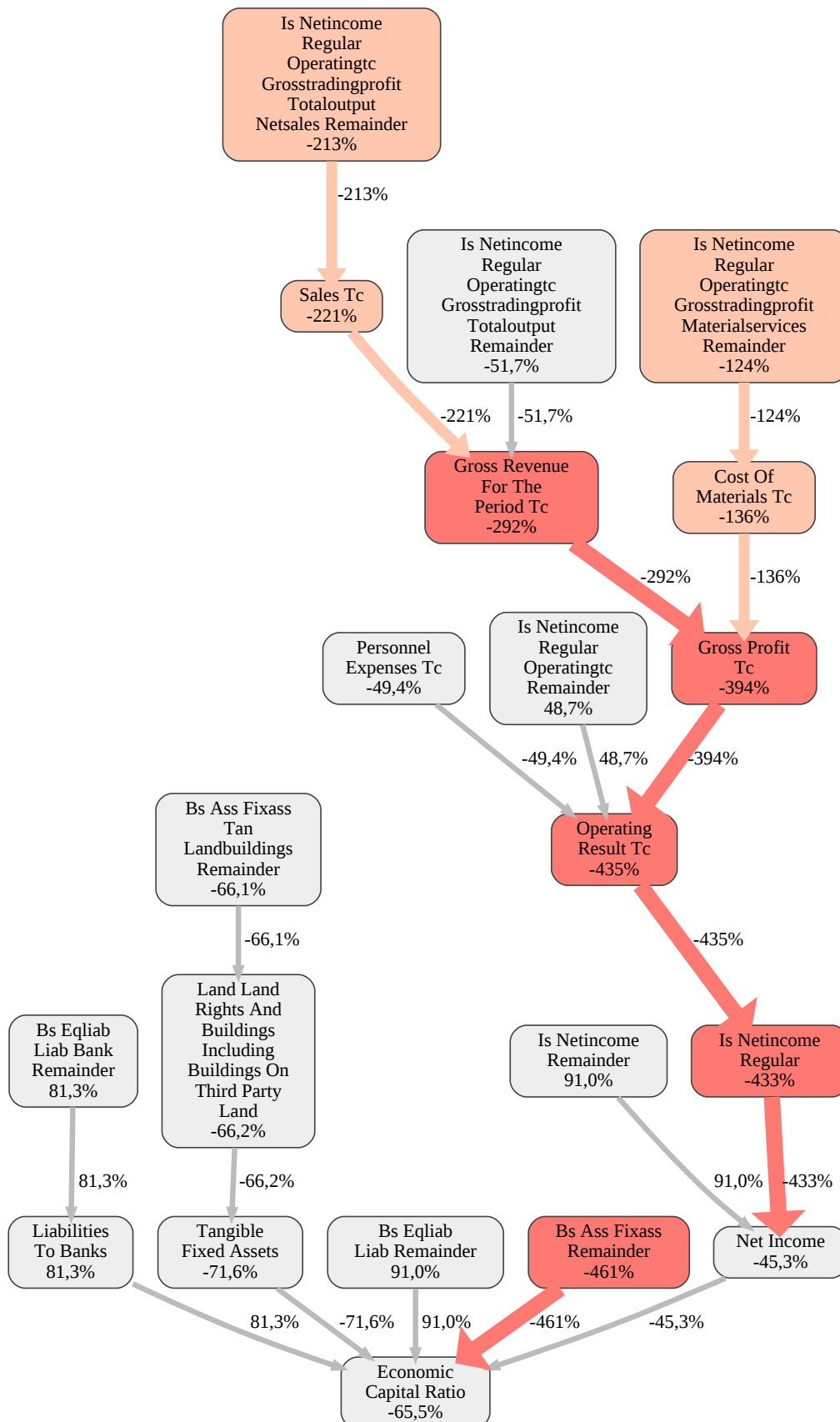




The relative strengths and weaknesses of Wohnungsbaugesellschaft der Lutherstadt Eisleben mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft der Lutherstadt Eisleben mbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 91% points. The greatest weakness of Wohnungsbaugesellschaft der Lutherstadt Eisleben mbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 461% points.

The company's Economic Capital Ratio, given in the ranking table, is 91%, being 65% points below the market average of 156%.
