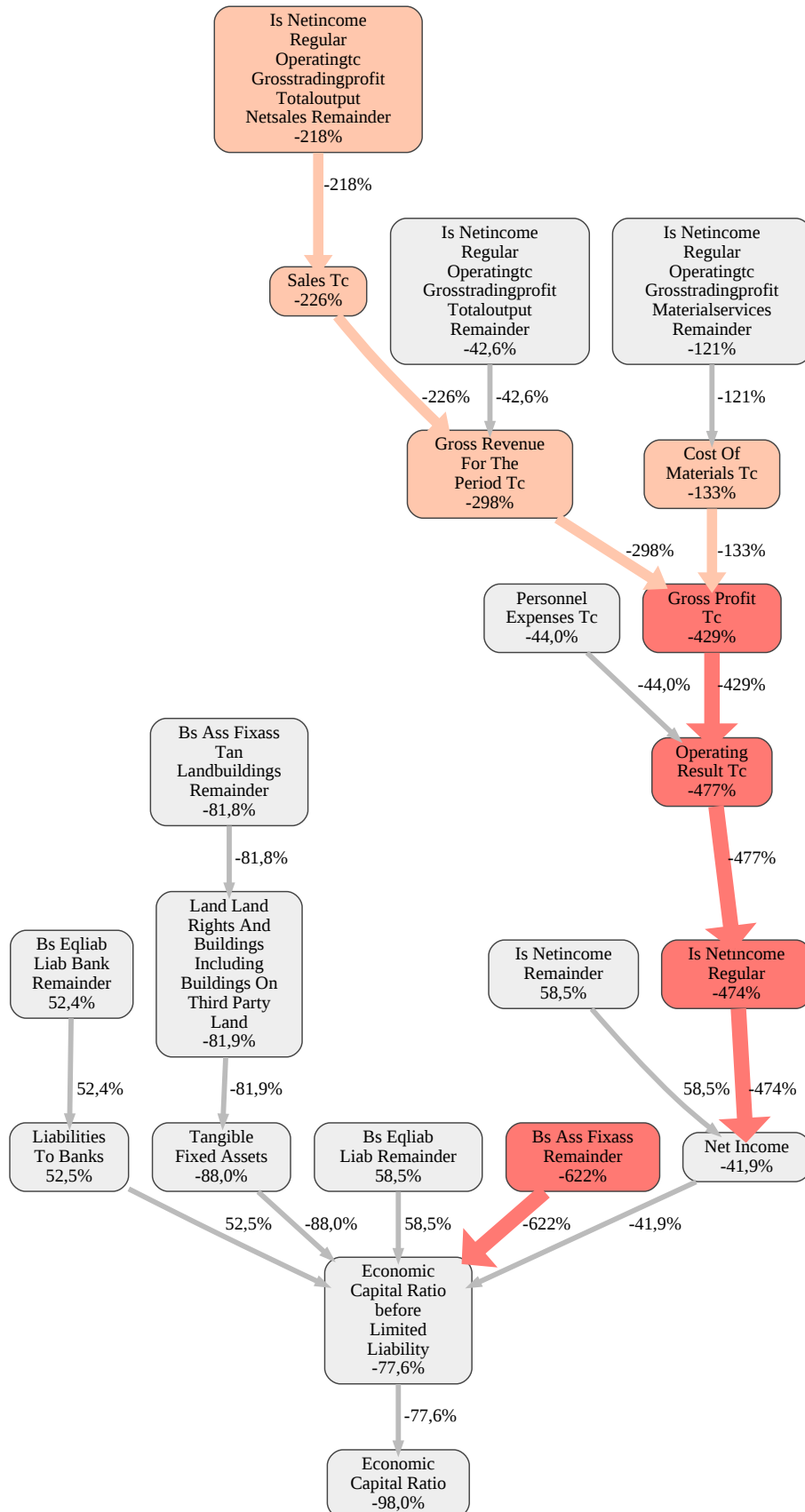




The relative strengths and weaknesses of Gemeinnützige Wohnungsbaugesellschaft mbH Wuppertal are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gemeinnützige Wohnungsbaugesellschaft mbH Wuppertal compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 58% points. The greatest weakness of Gemeinnützige Wohnungsbaugesellschaft mbH Wuppertal is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 622% points.

The company's Economic Capital Ratio, given in the ranking table, is 58%, being 98% points below the market average of 156%.
