



## ABG Frankfurt Holding Wohnungsbau und Beteiligungsgesellschaft

### Rank 169 of 366

The relative strengths and weaknesses of ABG Frankfurt Holding Wohnungsbau und Beteiligungsgesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ABG Frankfurt Holding Wohnungsbau und Beteiligungsgesellschaft compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 89% points. The greatest weakness of ABG Frankfurt Holding Wohnungsbau und Beteiligungsgesellschaft is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 469% points.

The company's Economic Capital Ratio, given in the ranking table, is 89%, being 68% points below the market average of 156%.
