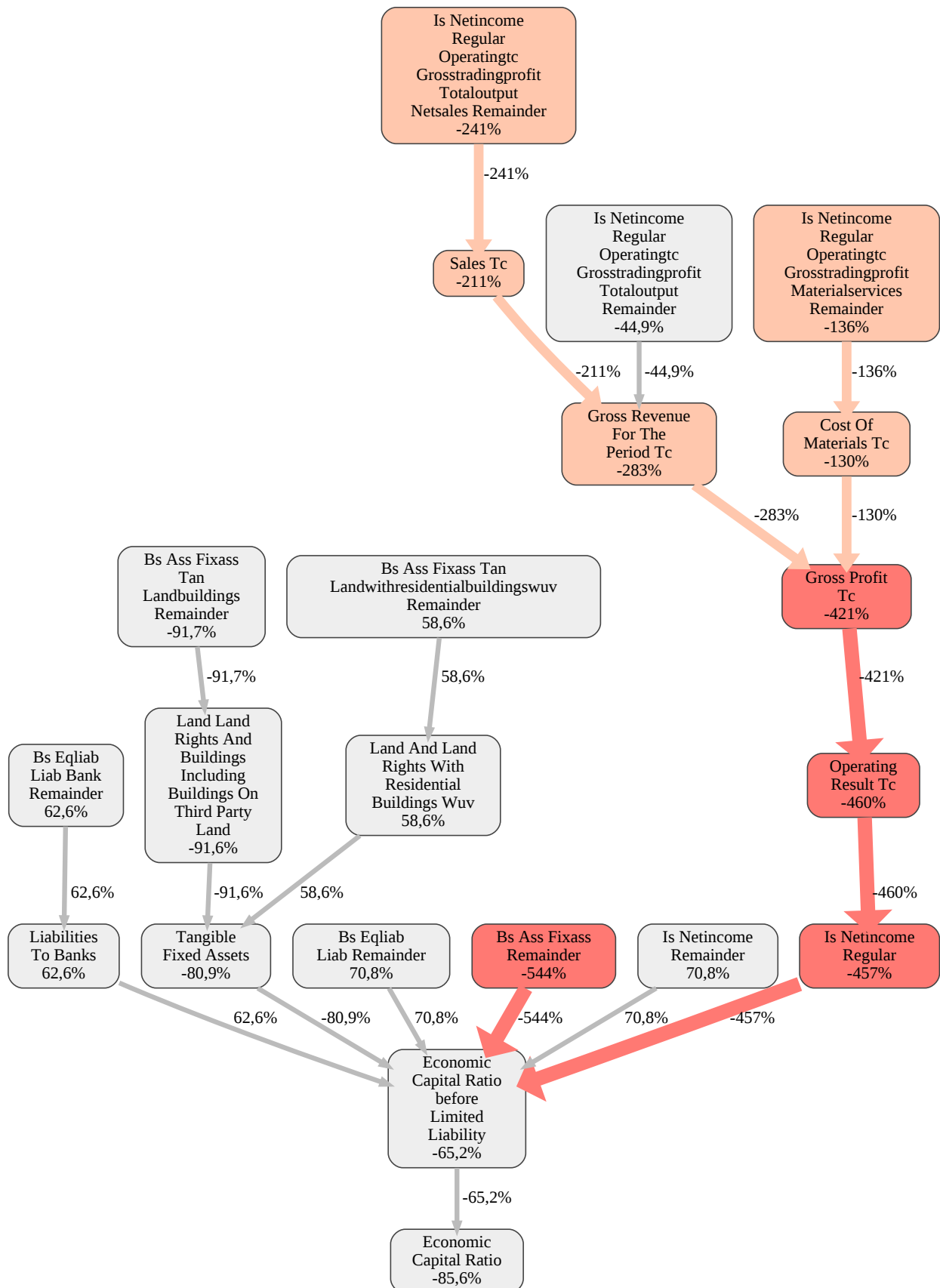




The relative strengths and weaknesses of WHG Wohnungsbau und Hausverwaltungs GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of WHG Wohnungsbau und Hausverwaltungs GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 71% points. The greatest weakness of WHG Wohnungsbau und Hausverwaltungs GmbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 544% points.

The company's Economic Capital Ratio, given in the ranking table, is 71%, being 86% points below the market average of 156%.
