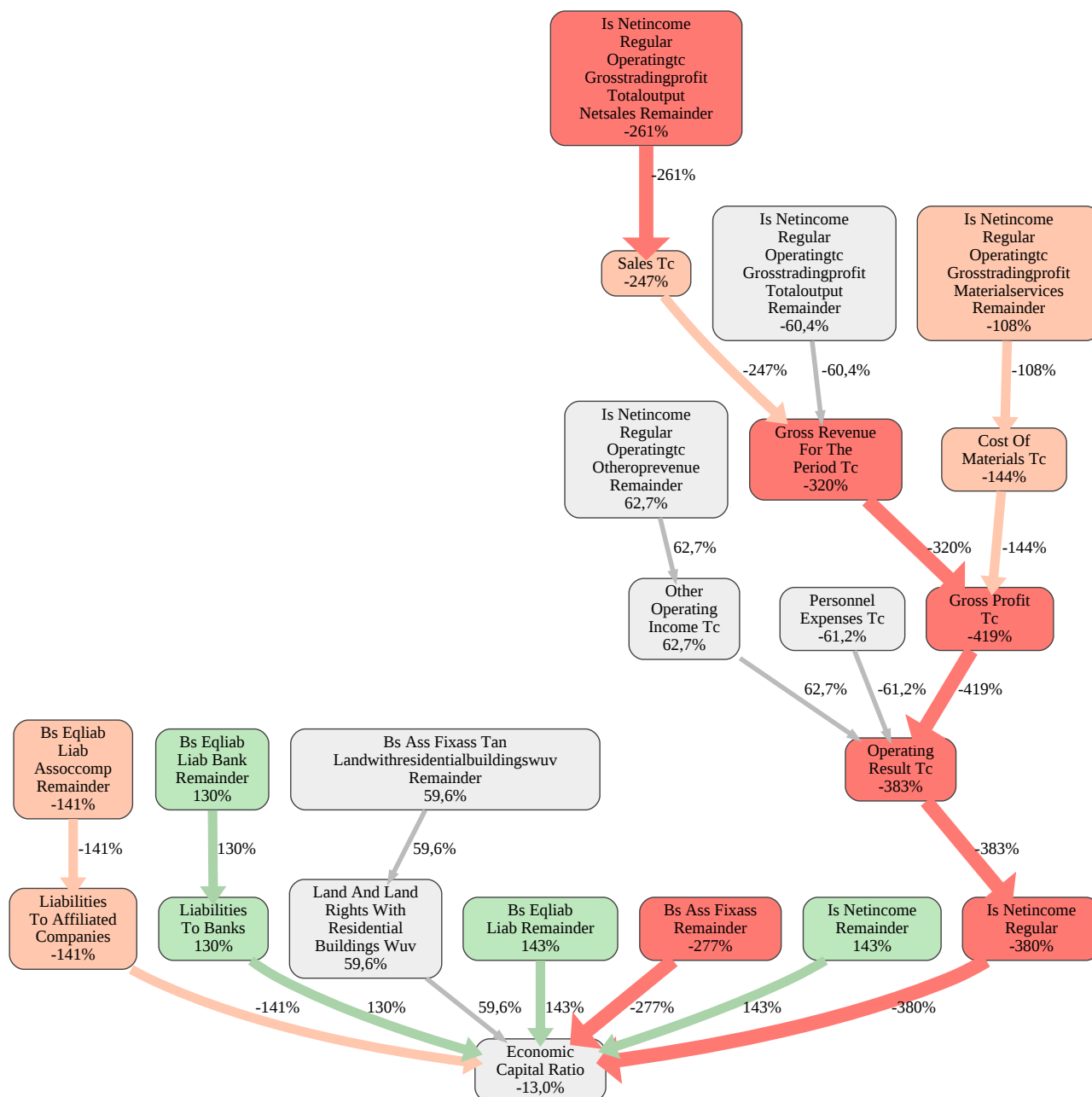




The relative strengths and weaknesses of Wohnungsbau Niedersachsen Gesellschaft mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau Niedersachsen Gesellschaft mit Beschränkter Haftung compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 143% points. The greatest weakness of Wohnungsbau Niedersachsen Gesellschaft mit Beschränkter Haftung is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 419% points.

The company's Economic Capital Ratio, given in the ranking table, is 143%, being 13% points below the market average of 156%.
