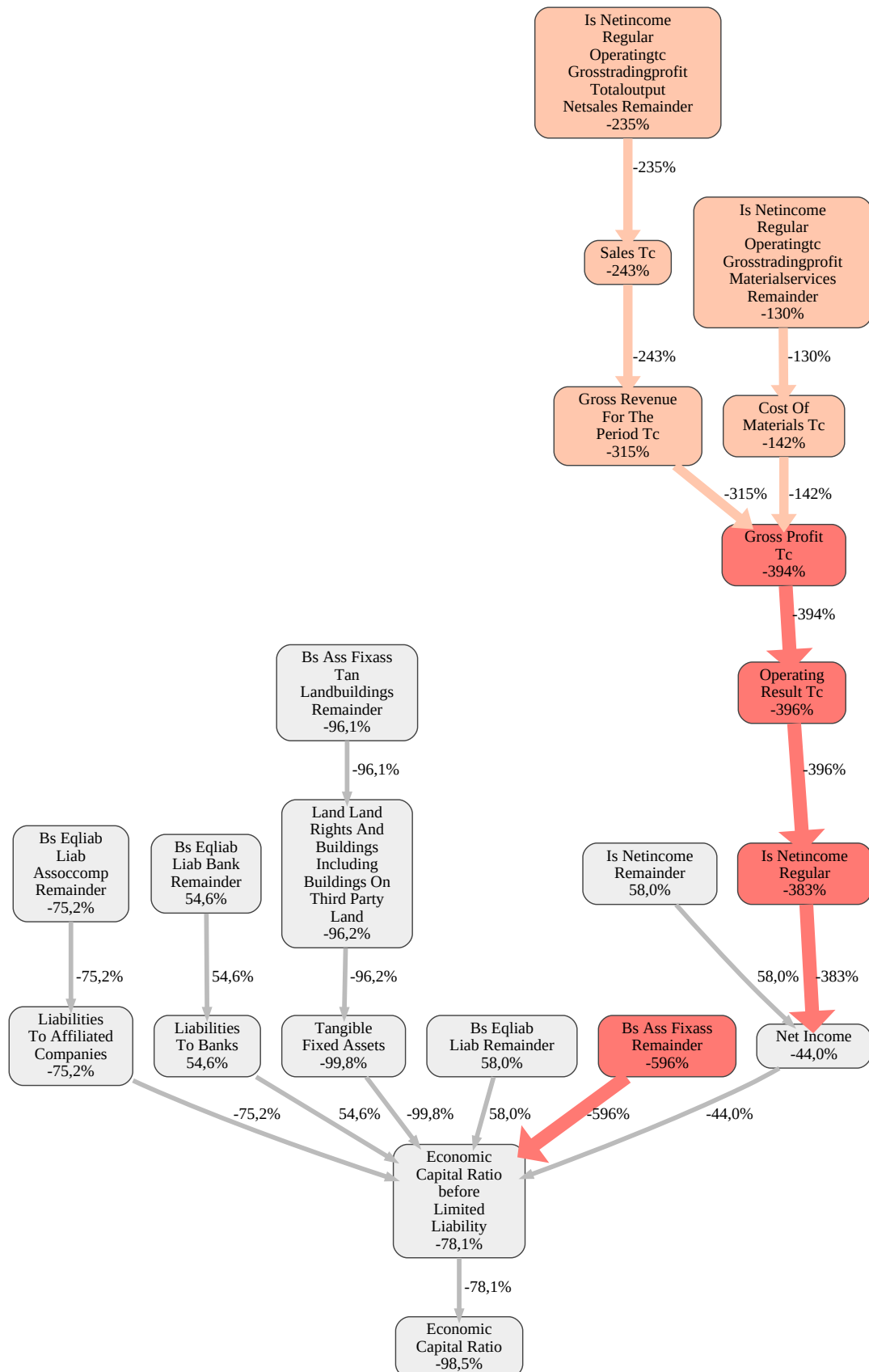




The relative strengths and weaknesses of Heberger GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Heberger GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 58% points. The greatest weakness of Heberger GmbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 596% points.

The company's Economic Capital Ratio, given in the ranking table, is 58%, being 98% points below the market average of 156%.
