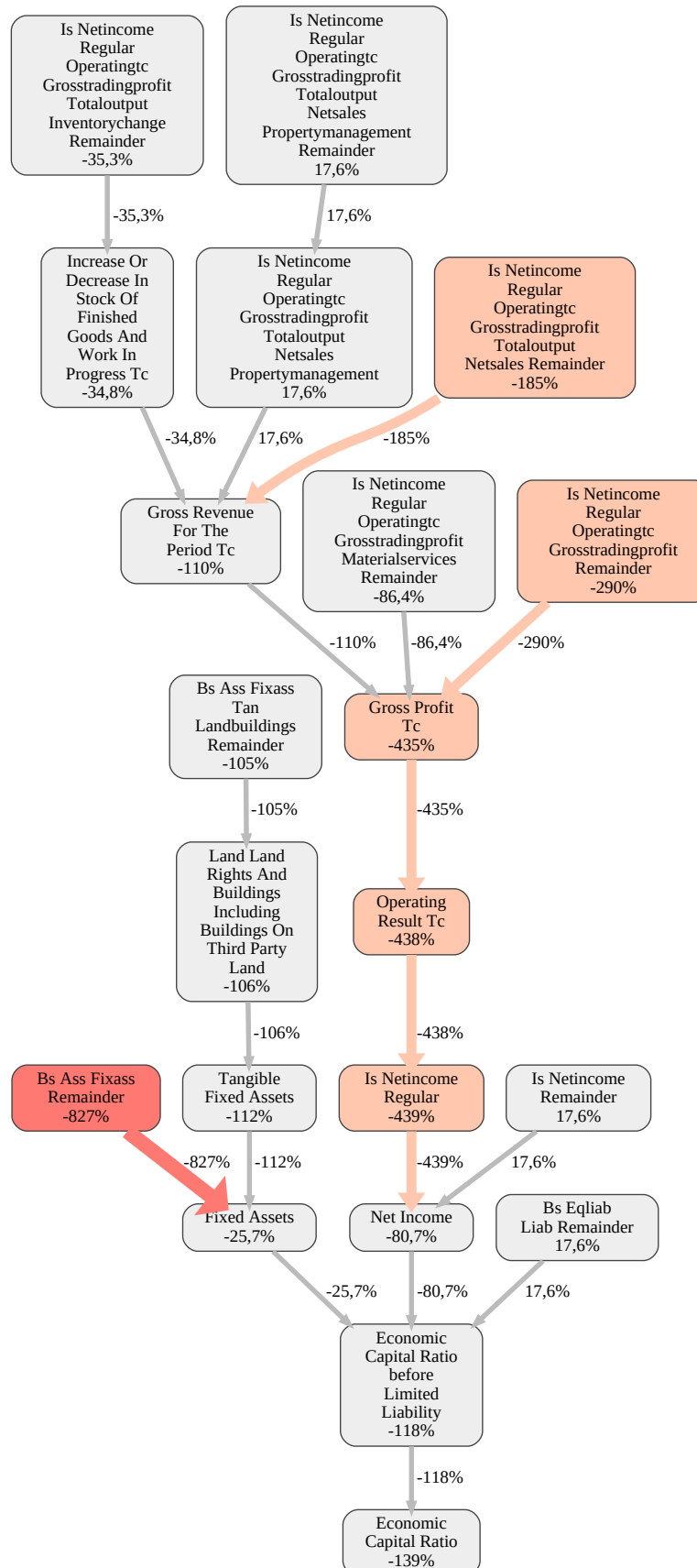




The relative strengths and weaknesses of BBS Bau und Betriebsservice GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BBS Bau und Betriebsservice GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 18% points. The greatest weakness of BBS Bau und Betriebsservice GmbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 827% points.

The company's Economic Capital Ratio, given in the ranking table, is 18%, being 139% points below the market average of 156%.
