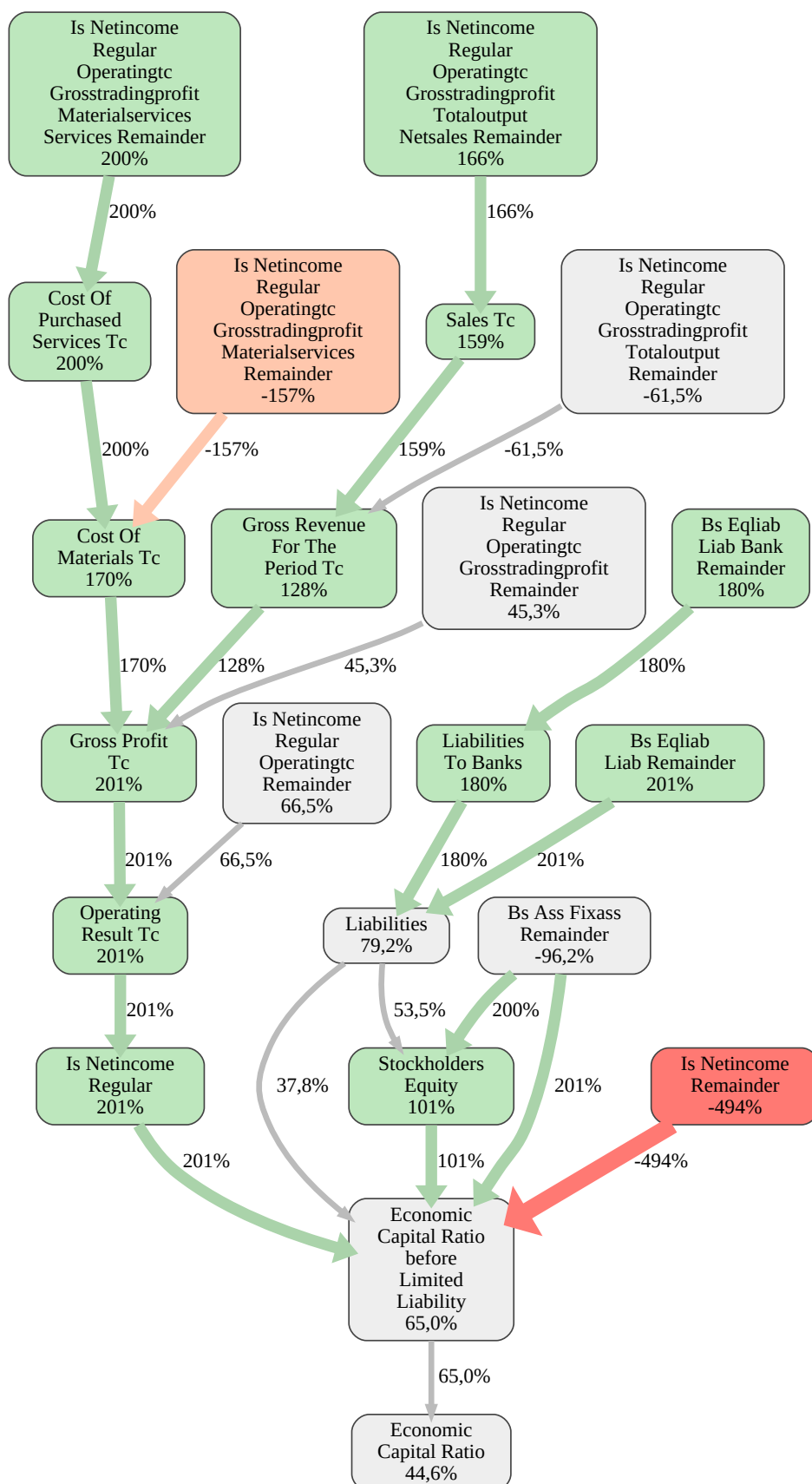




The relative strengths and weaknesses of Bremer AG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bremer AG compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 201% points. The greatest weakness of Bremer AG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 494% points.

The company's Economic Capital Ratio, given in the ranking table, is 201%, being 45% points above the market average of 156%.
