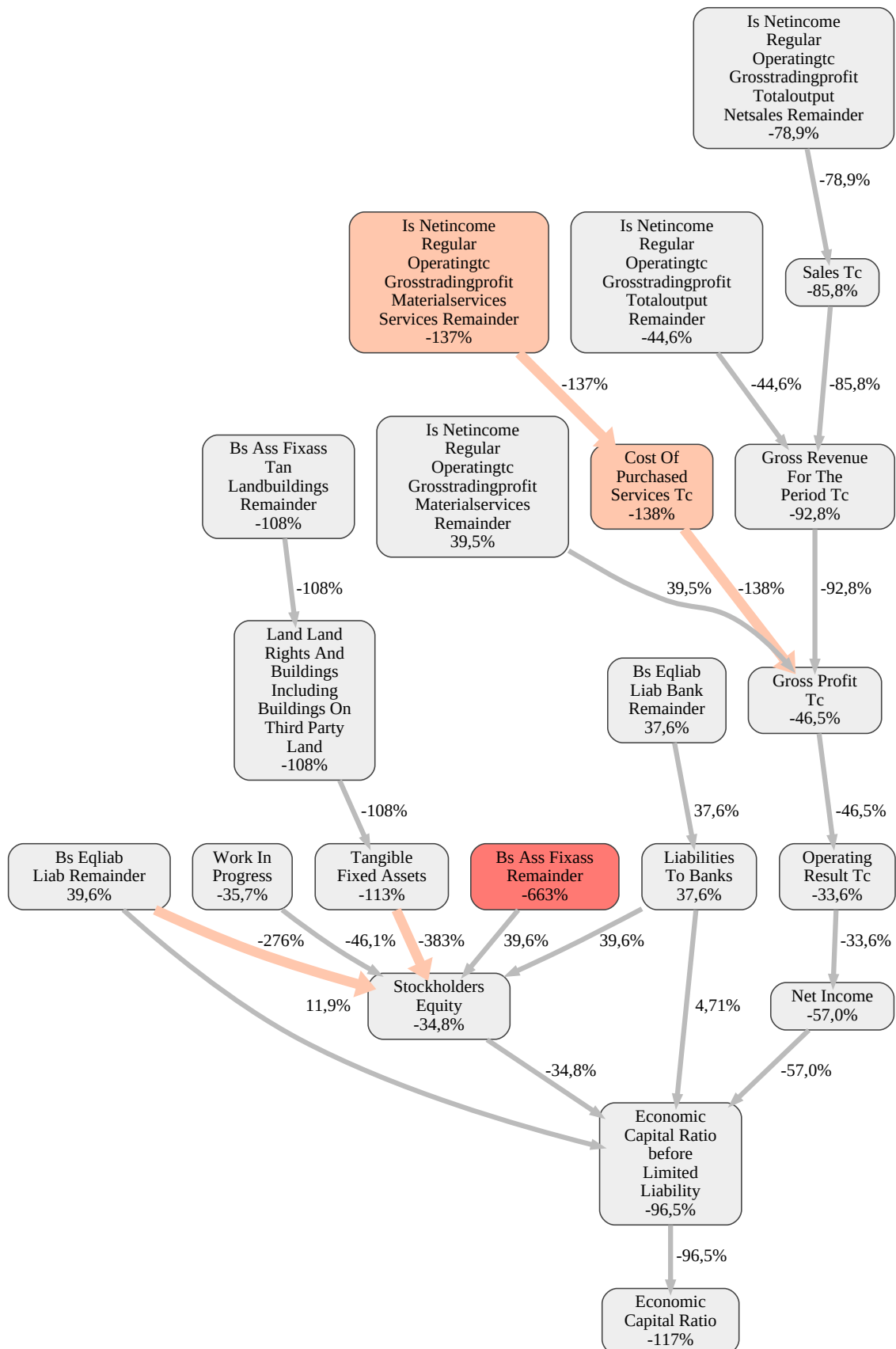




The relative strengths and weaknesses of Implenla Hochbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Implenla Hochbau GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 40% points. The greatest weakness of Implenla Hochbau GmbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 663% points.

The company's Economic Capital Ratio, given in the ranking table, is 40%, being 117% points below the market average of 156%.
