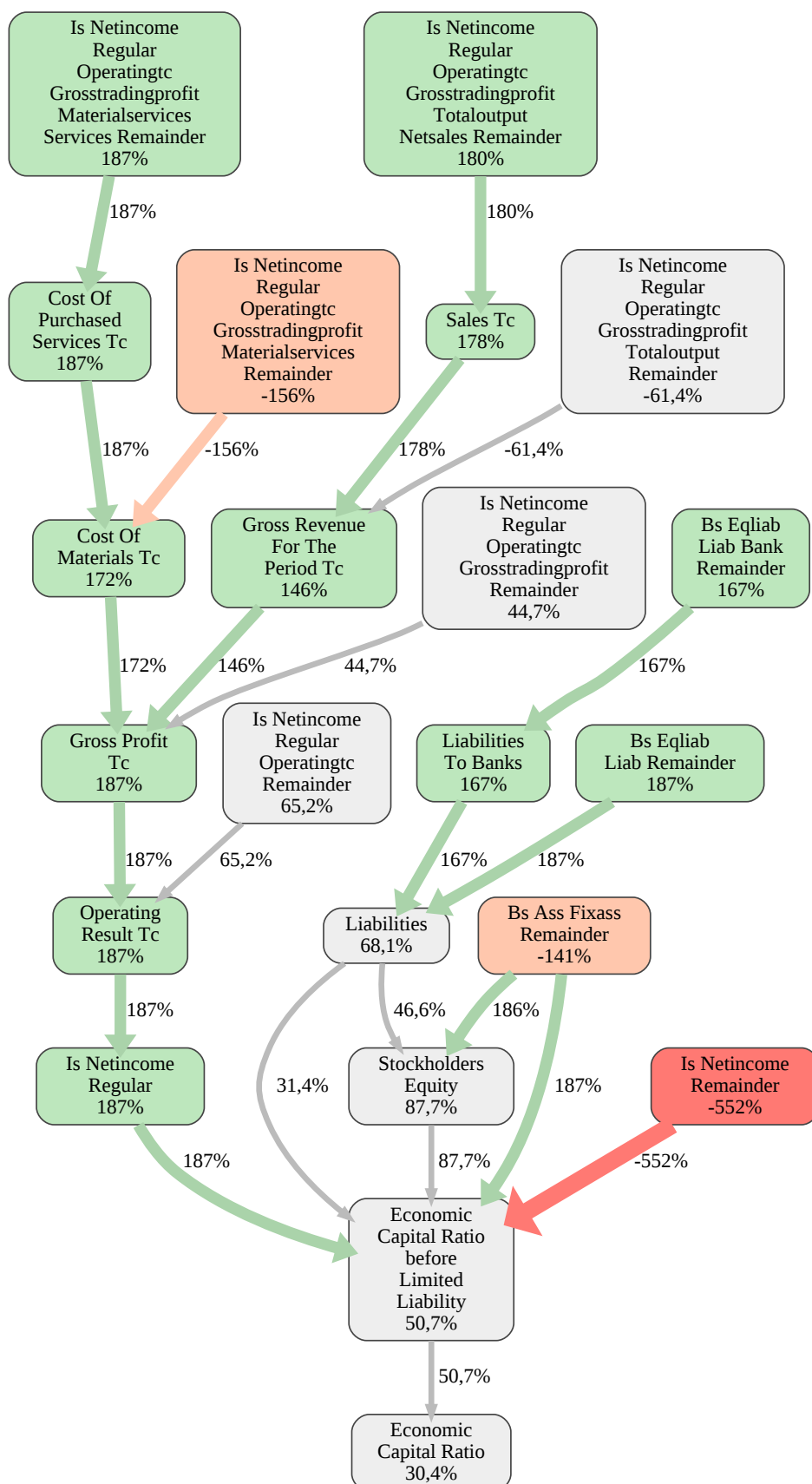




The relative strengths and weaknesses of Bremer AG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bremer AG Konzern compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 187% points. The greatest weakness of Bremer AG Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 552% points.

The company's Economic Capital Ratio, given in the ranking table, is 187%, being 30% points above the market average of 156%.
