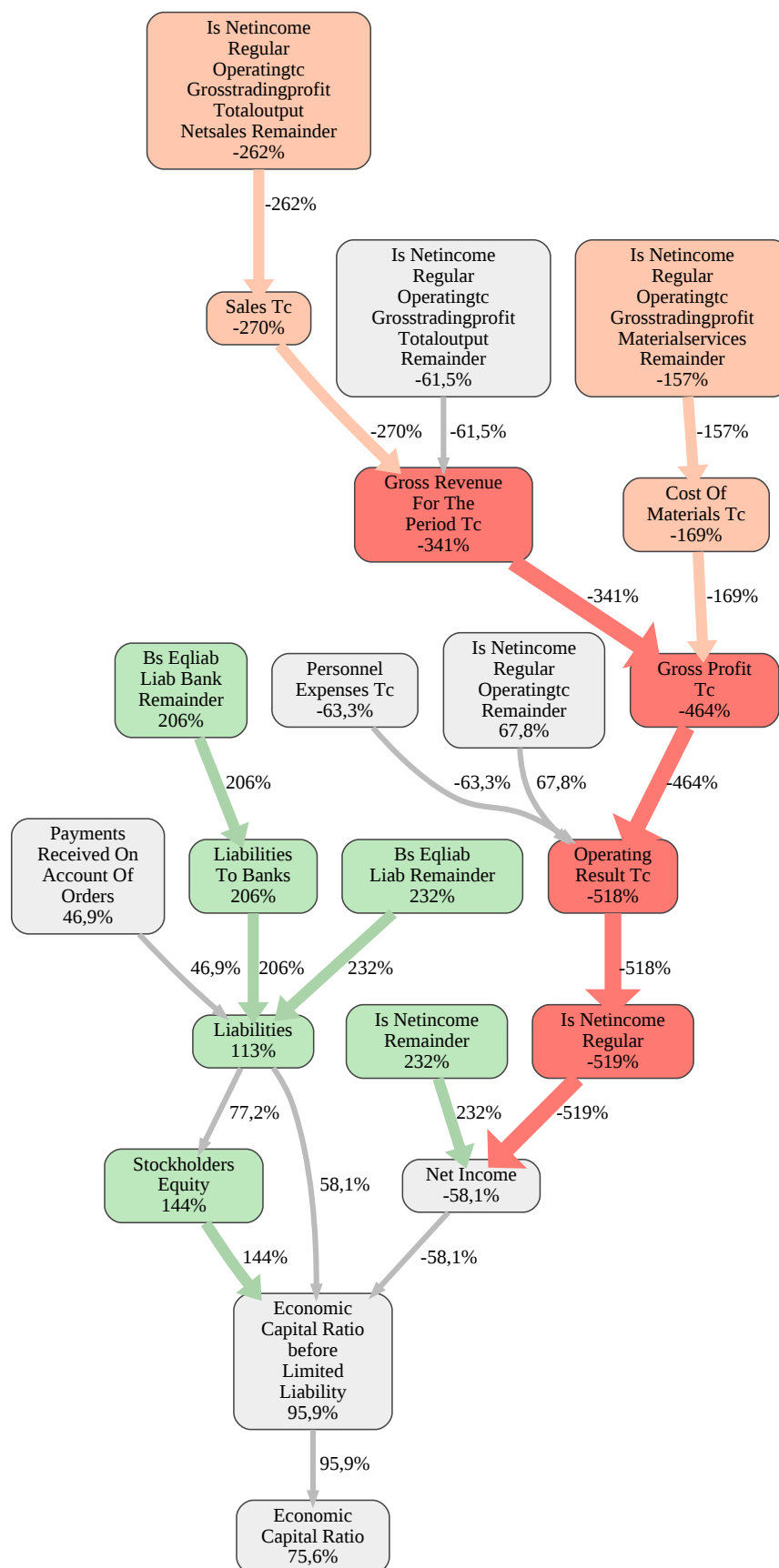




The relative strengths and weaknesses of Takenaka Europe GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Takenaka Europe GmbH Konzern compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 232% points. The greatest weakness of Takenaka Europe GmbH Konzern is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 519% points.

The company's Economic Capital Ratio, given in the ranking table, is 232%, being 76% points above the market average of 156%.
