The greatest weakness of Gesobau AG Konzern is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 550% points.

The company's Economic Capital Ratio, given in the ranking table, is 69%, being 87% points below the market average of 156%.


