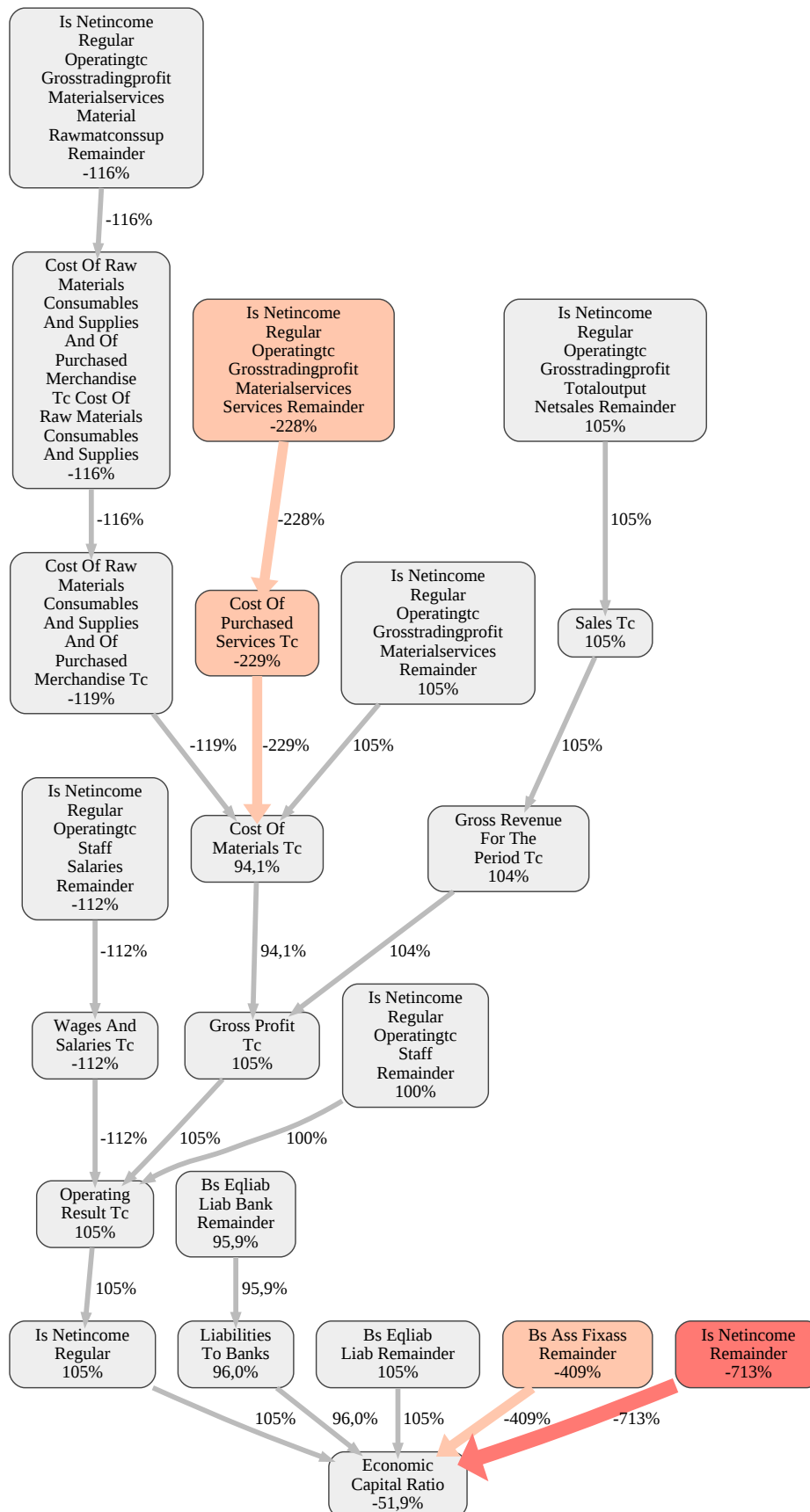

The greatest strength of Rensch GmbH Co Grundstücksverwaltung KG Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 105% points. The greatest weakness of Rensch GmbH Co Grundstücksverwaltung KG Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 713% points.

The company's Economic Capital Ratio, given in the ranking table, is 105%, being 52% points below the market average of 156%.
