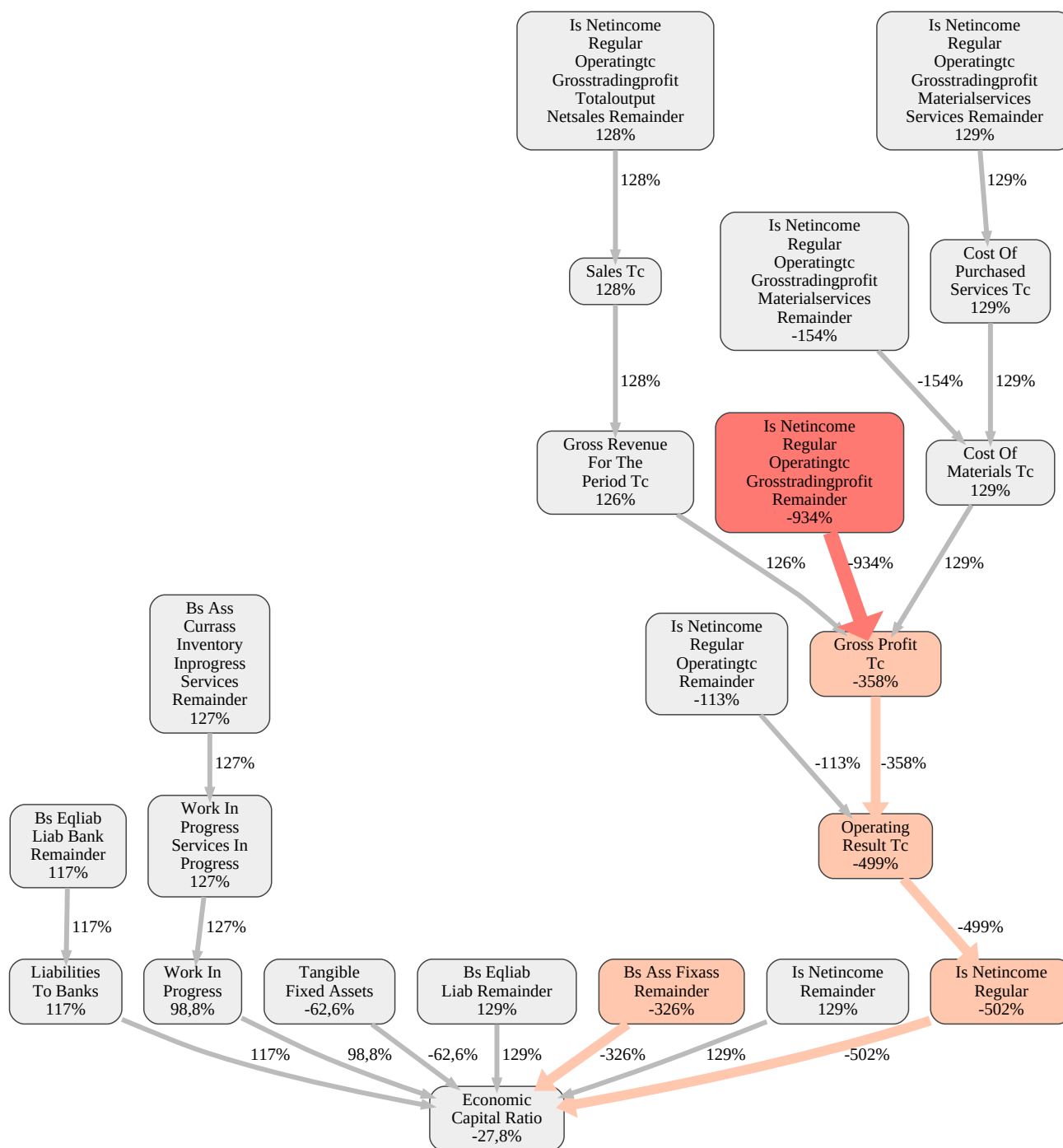




The relative strengths and weaknesses of B O Wohnungswirtschaft GmbH Chemnitz Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of B O Wohnungswirtschaft GmbH Chemnitz Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 129% points. The greatest weakness of B O Wohnungswirtschaft GmbH Chemnitz Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 934% points.

The company's Economic Capital Ratio, given in the ranking table, is 129%, being 28% points below the market average of 156%.
