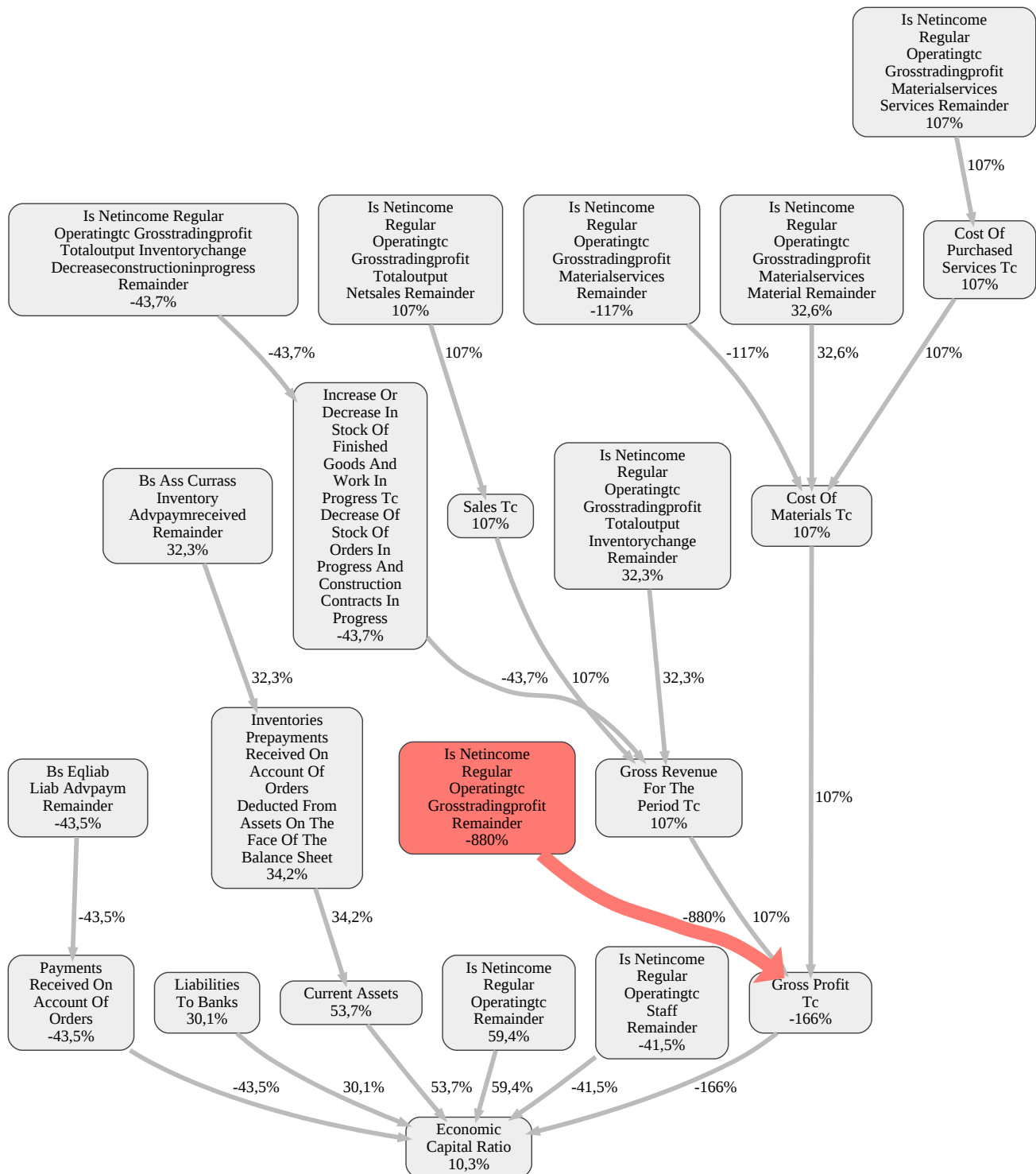

The greatest strength of Krüger Bau Bernau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Remainder, increasing the Economic Capital Ratio by 107% points. The greatest weakness of Krüger Bau Bernau GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 880% points.

The company's Economic Capital Ratio, given in the ranking table, is 107%, being 10% points above the market average of 97%.
