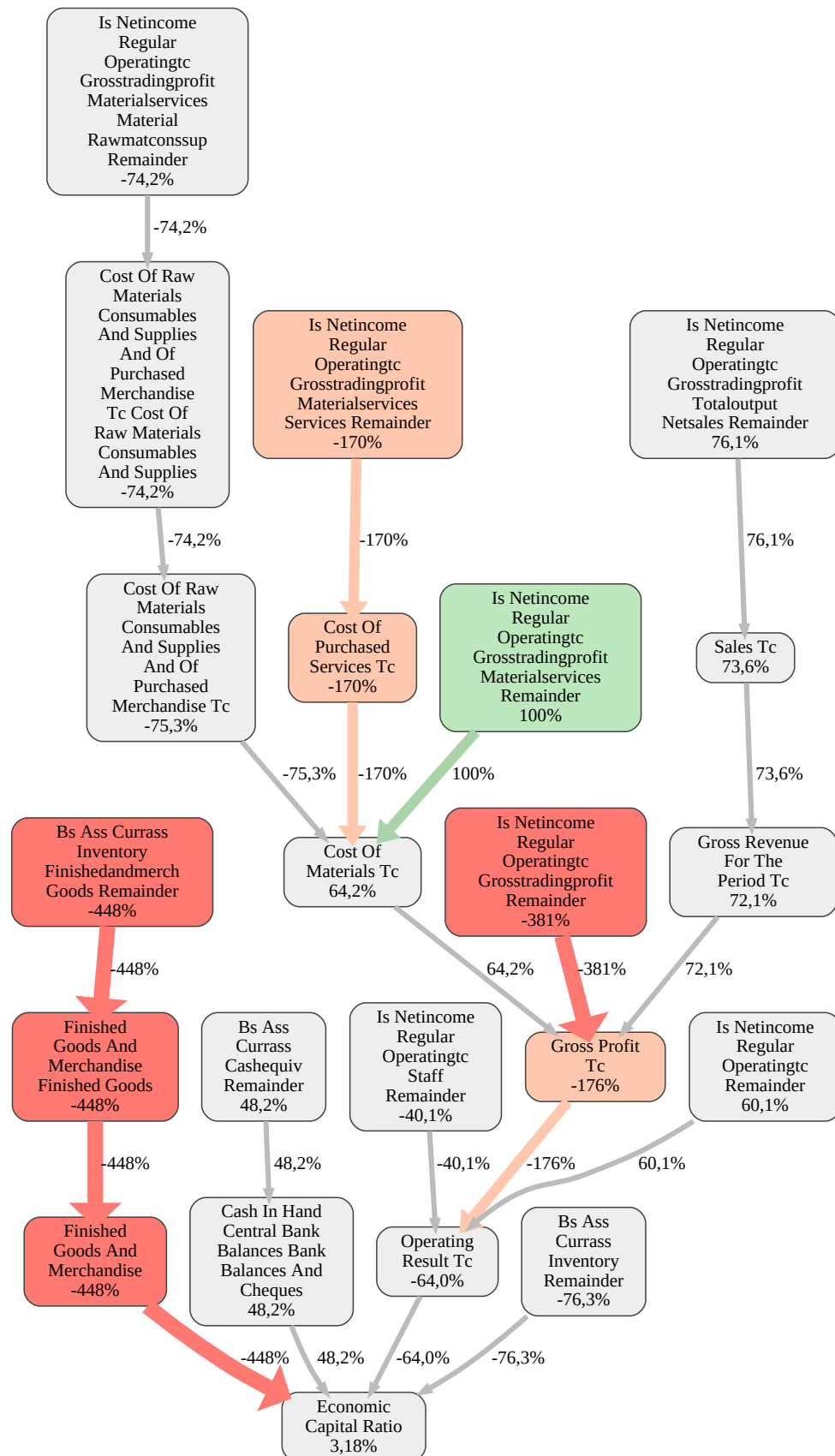

The greatest strength of Mayerhofer Hoch Tief und Ingenieurbau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 100% points. The greatest weakness of Mayerhofer Hoch Tief und Ingenieurbau GmbH is the variable Finished Goods And Merchandise, reducing the Economic Capital Ratio by 448% points.

The company's Economic Capital Ratio, given in the ranking table, is 100%, being 3,2% points above the market average of 97%.
