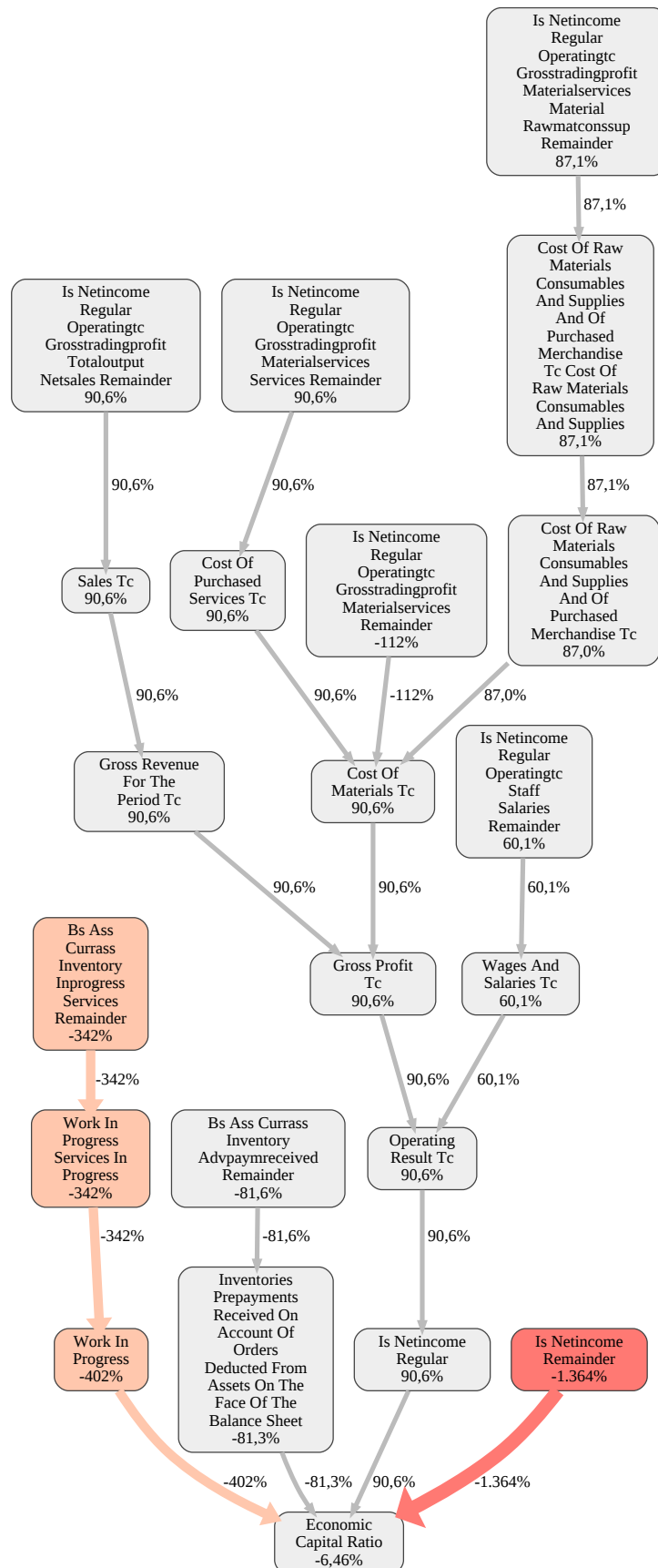




The relative strengths and weaknesses of Bauunternehmung Karl Gemünden GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Karl Gemünden GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Remainder, increasing the Economic Capital Ratio by 91% points. The greatest weakness of Bauunternehmung Karl Gemünden GmbH Co KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 1.364% points.

The company's Economic Capital Ratio, given in the ranking table, is 91%, being 6,5% points below the market average of 97%.
