

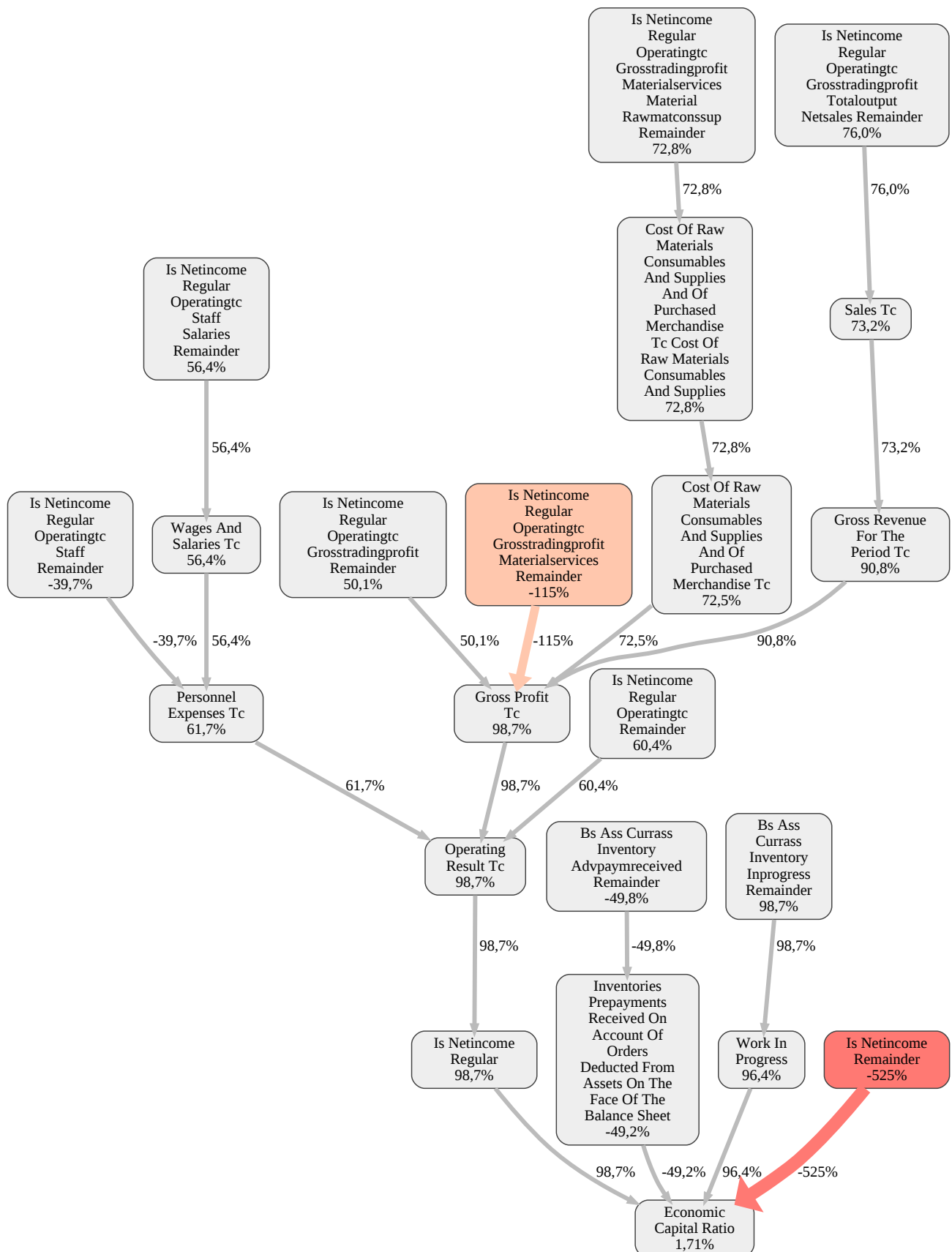

The relative strengths and weaknesses of Xaver Lutzenberger GmbH Co KG Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Xaver Lutzenberger GmbH Co KG Bauunternehmung compared to the market average is the variable Bs Ass Currass Inventory Inprogress Remainder, increasing the Economic Capital Ratio by 99% points. The greatest weakness of Xaver Lutzenberger GmbH Co KG Bauunternehmung is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 525% points.

The company's Economic Capital Ratio, given in the ranking table, is 99%, being 1,7% points above the market average of 97%.
