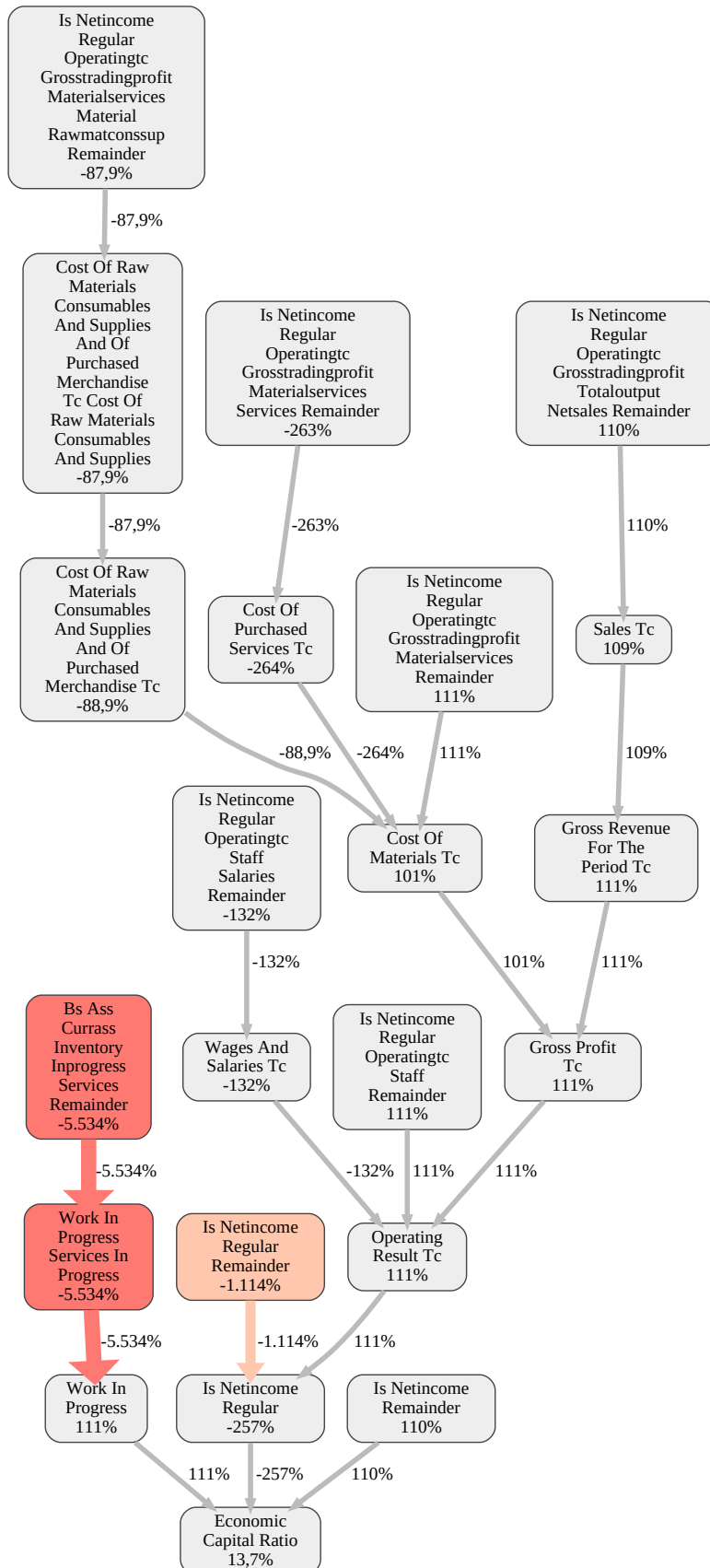




The relative strengths and weaknesses of Josef Pfaffinger Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Pfaffinger Bauunternehmung GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 111% points. The greatest weakness of Josef Pfaffinger Bauunternehmung GmbH is the variable Bs Ass Currass Inventory Inprogress Services Remainder, reducing the Economic Capital Ratio by 5.534% points.

The company's Economic Capital Ratio, given in the ranking table, is 111%, being 14% points above the market average of 97%.
