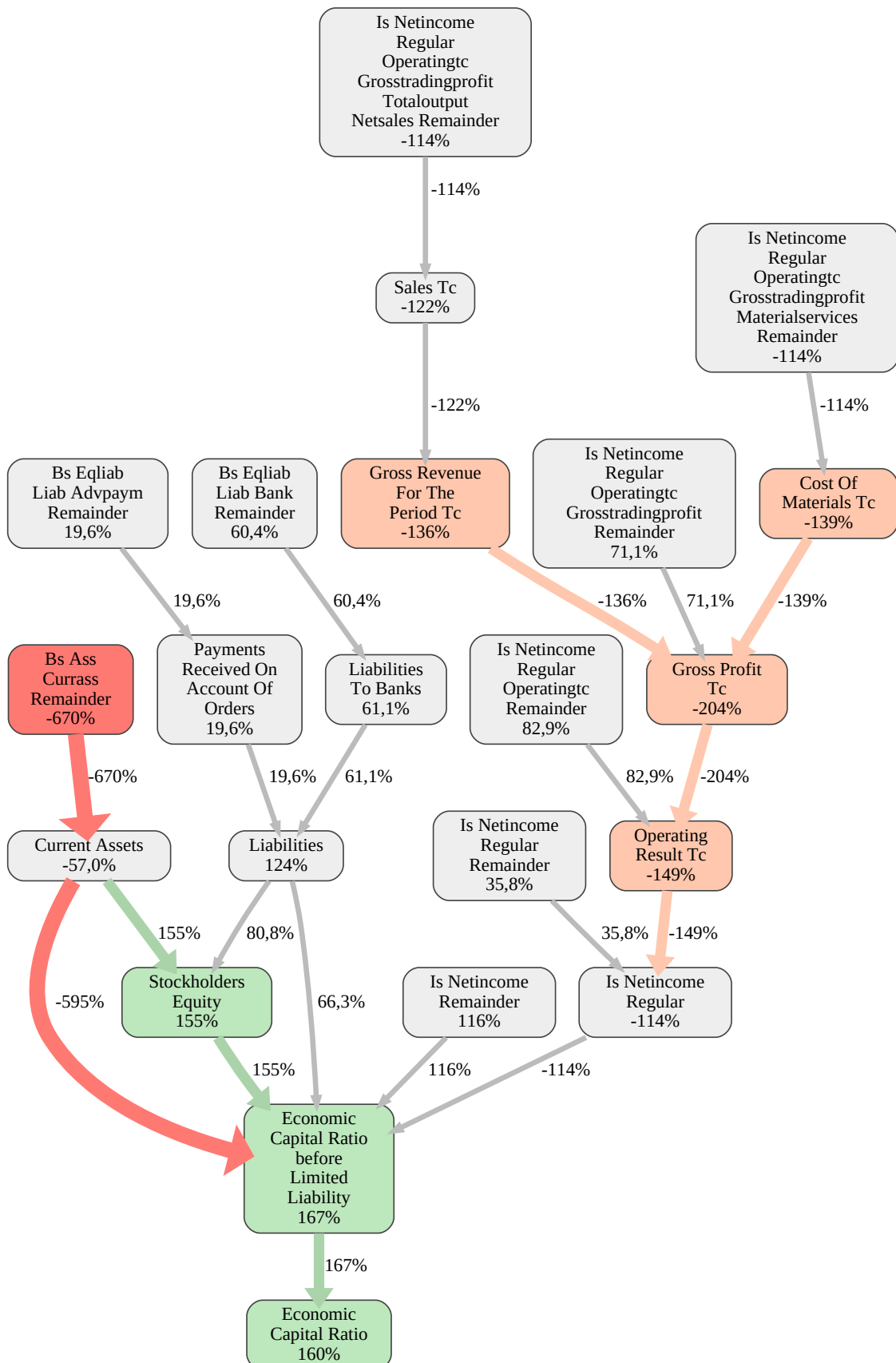




The relative strengths and weaknesses of Otto Maier GmbH Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Otto Maier GmbH Bauunternehmung compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 155% points. The greatest weakness of Otto Maier GmbH Bauunternehmung is the variable Bs Ass Currass Remainder, reducing the Economic Capital Ratio by 670% points.

The company's Economic Capital Ratio, given in the ranking table, is 257%, being 160% points above the market average of 97%.
