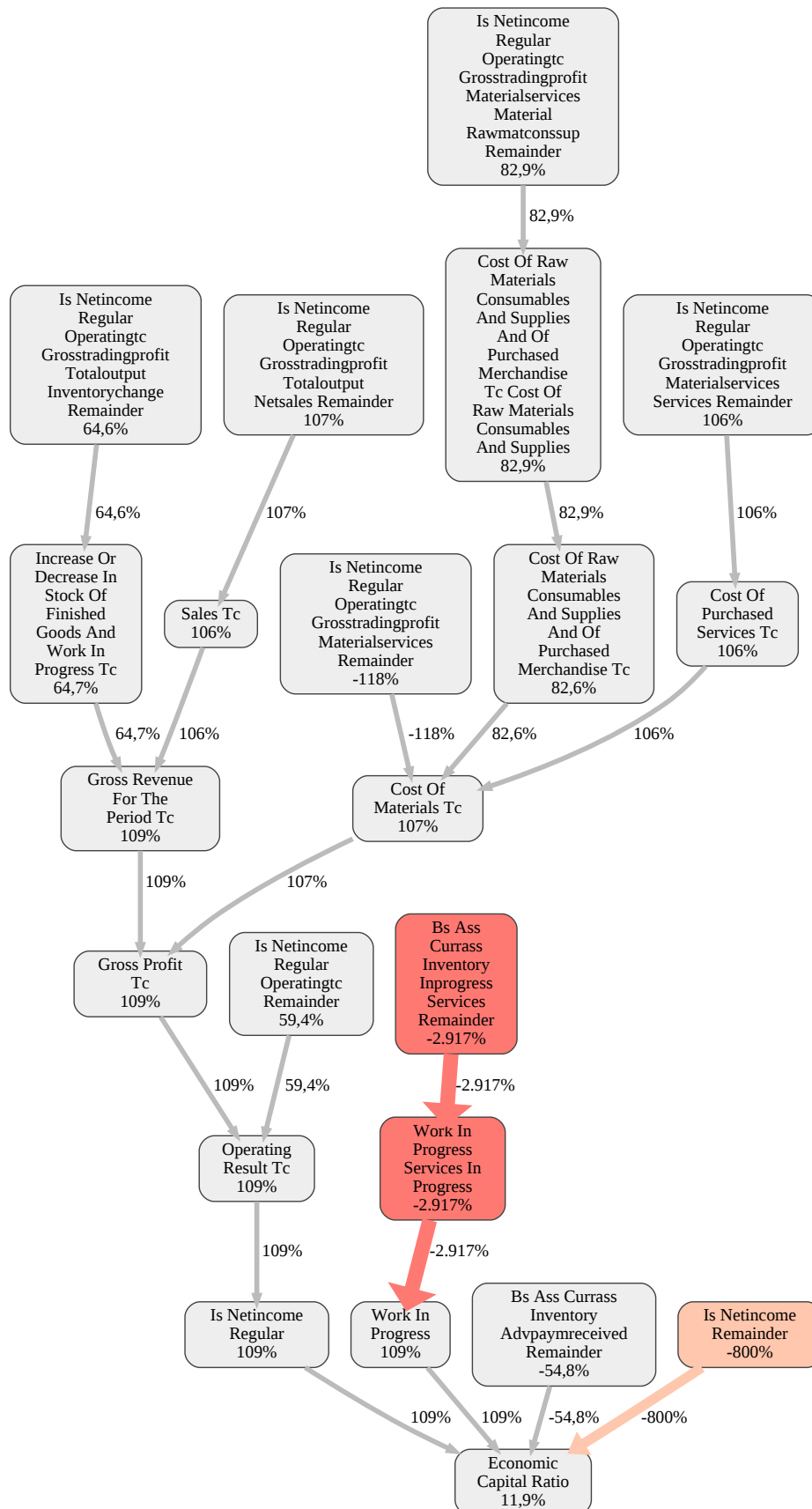




The relative strengths and weaknesses of Dechant hoch und Ingenieurbau gmbh are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dechant hoch und Ingenieurbau gmbh compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 109% points. The greatest weakness of Dechant hoch und Ingenieurbau gmbh is the variable Bs Ass Currass Inventory Inprogress Services Remainder, reducing the Economic Capital Ratio by 2.917% points.

The company's Economic Capital Ratio, given in the ranking table, is 109%, being 12% points above the market average of 97%.
