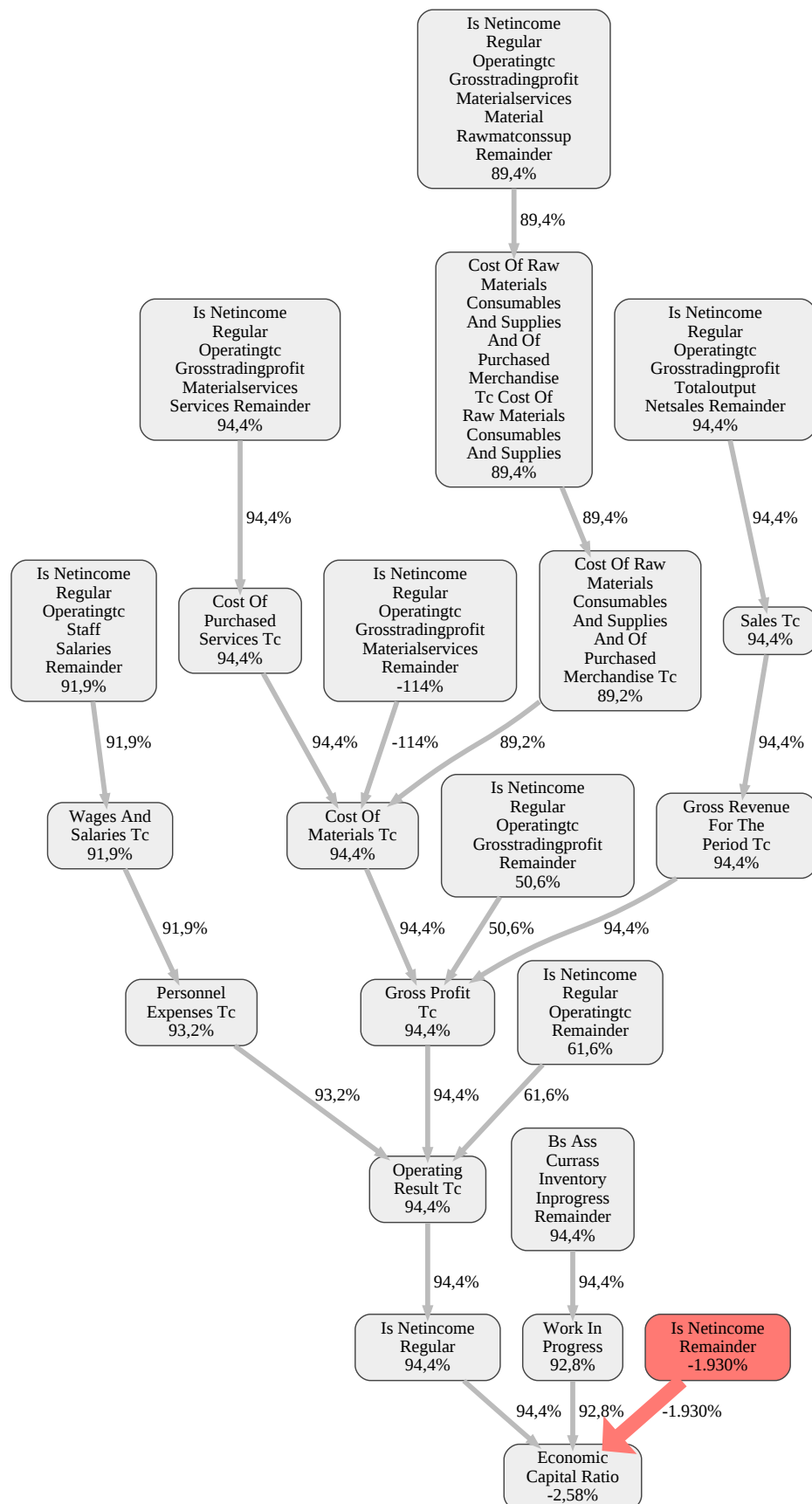

The greatest strength of Brüninghoff GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Remainder, increasing the Economic Capital Ratio by 94% points. The greatest weakness of Brüninghoff GmbH Co KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 1.930% points.

The company's Economic Capital Ratio, given in the ranking table, is 94%, being 2,6% points below the market average of 97%.
