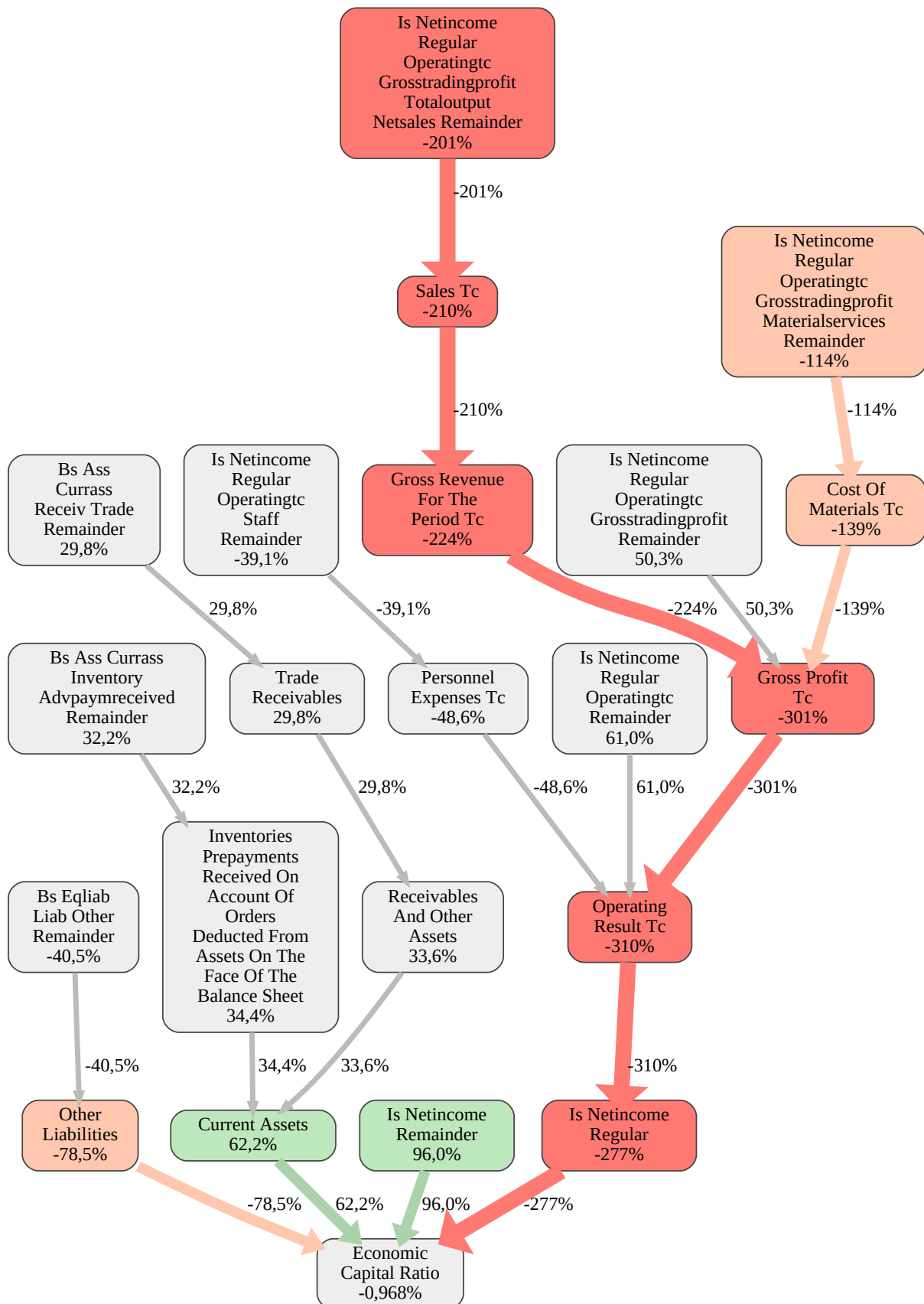




The relative strengths and weaknesses of Bauhof West Service GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauhof West Service GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 96% points. The greatest weakness of Bauhof West Service GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 310% points.

The company's Economic Capital Ratio, given in the ranking table, is 96%, being 0,97% points below the market average of 97%.
