

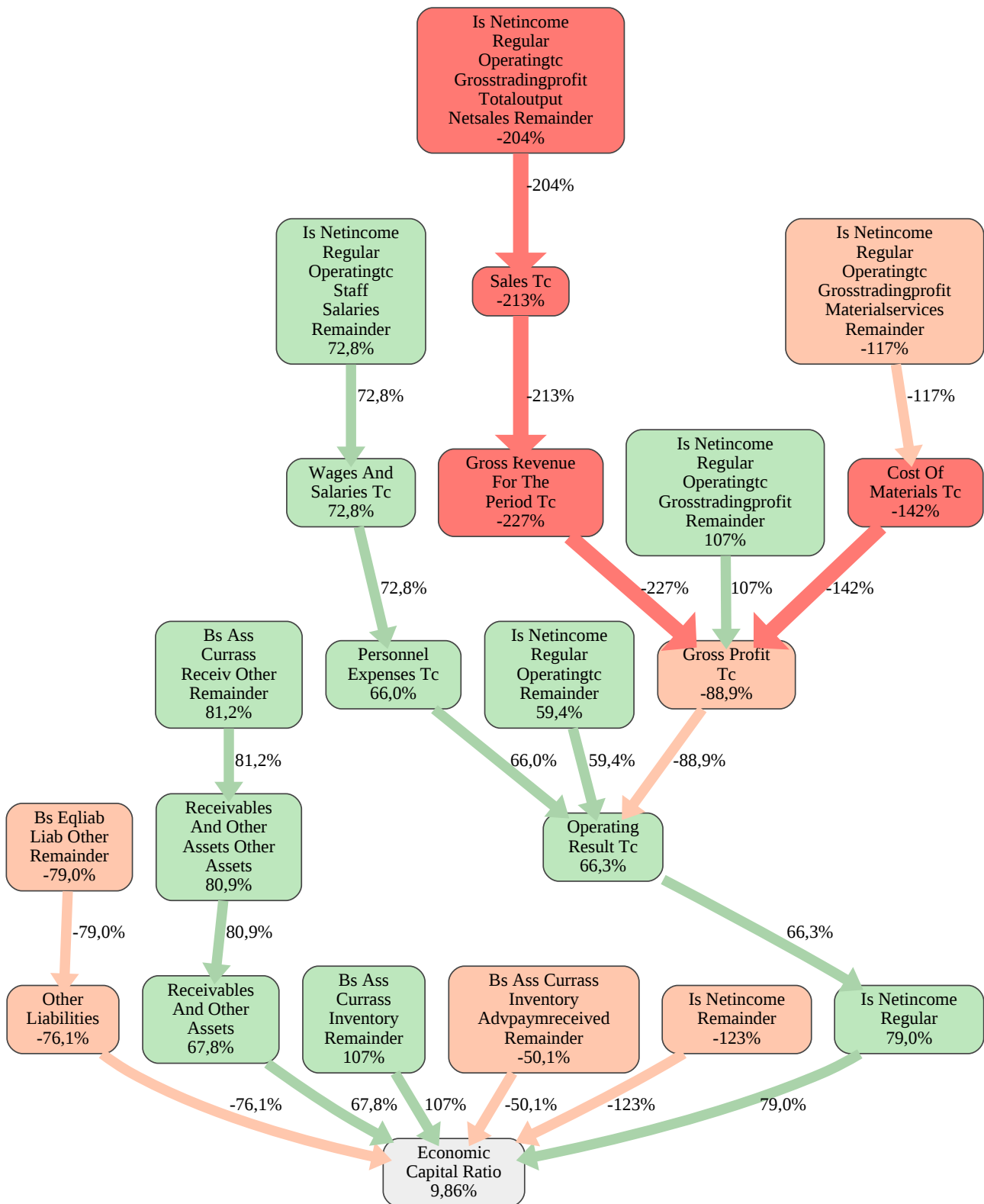

The relative strengths and weaknesses of Laudemann GmbH Bauunternehmen are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Laudemann GmbH Bauunternehmen compared to the market average is the variable Bs Ass Currass Inventory Remainder, increasing the Economic Capital Ratio by 107% points. The greatest weakness of Laudemann GmbH Bauunternehmen is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 227% points.

The company's Economic Capital Ratio, given in the ranking table, is 107%, being 9,9% points above the market average of 97%.
