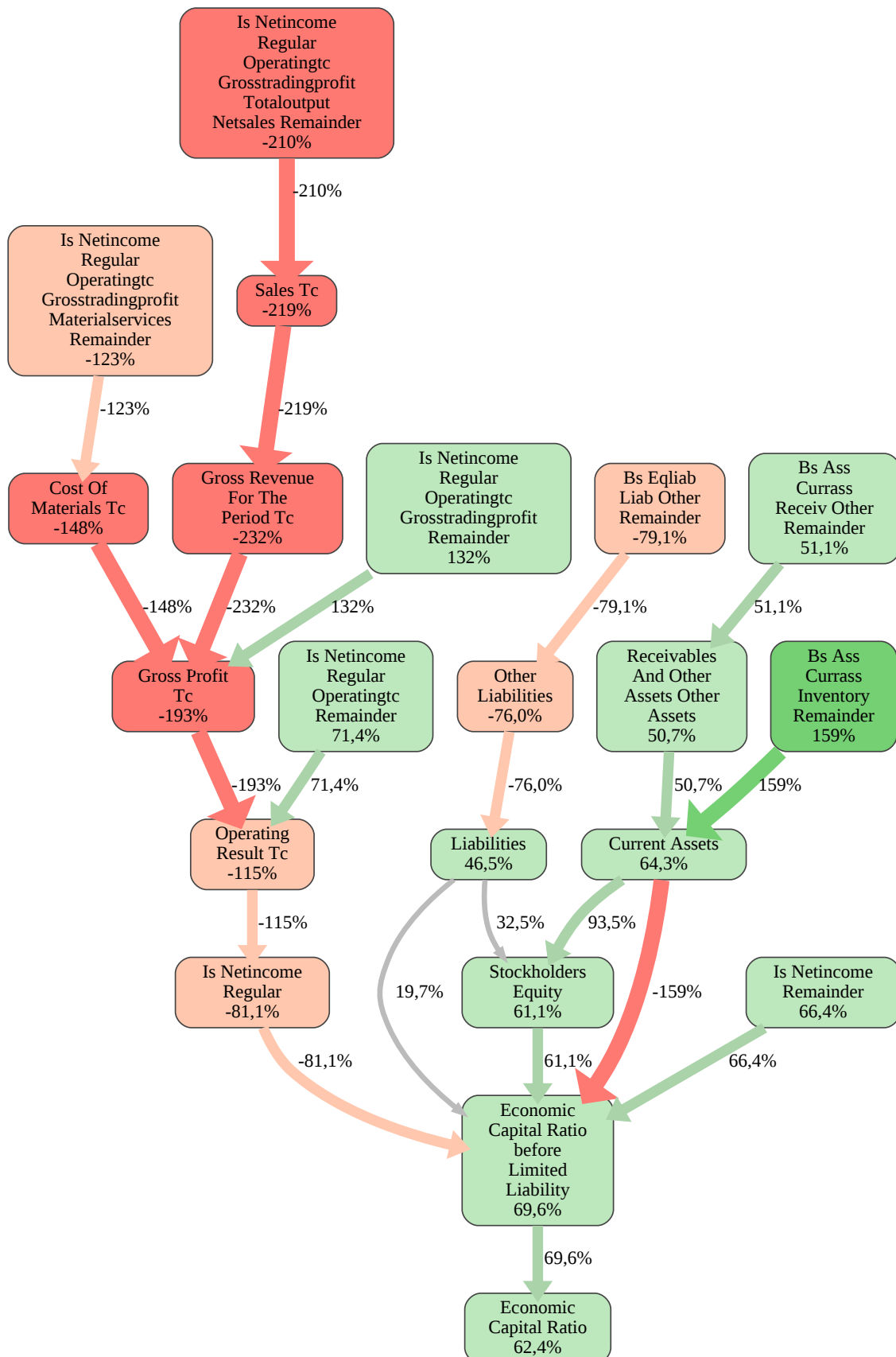




The relative strengths and weaknesses of Giebel Hoch und Tiefbau AG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Giebel Hoch und Tiefbau AG compared to the market average is the variable Bs Ass Currass Inventory Remainder, increasing the Economic Capital Ratio by 159% points. The greatest weakness of Giebel Hoch und Tiefbau AG is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 232% points.

The company's Economic Capital Ratio, given in the ranking table, is 159%, being 62% points above the market average of 97%.
