



The relative strengths and weaknesses of Rensch Haus GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Rensch Haus GmbH compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 122% points. The greatest weakness of Rensch Haus GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 914% points.

The company's Economic Capital Ratio, given in the ranking table, is 122%, being 25% points above the market average of 97%.
