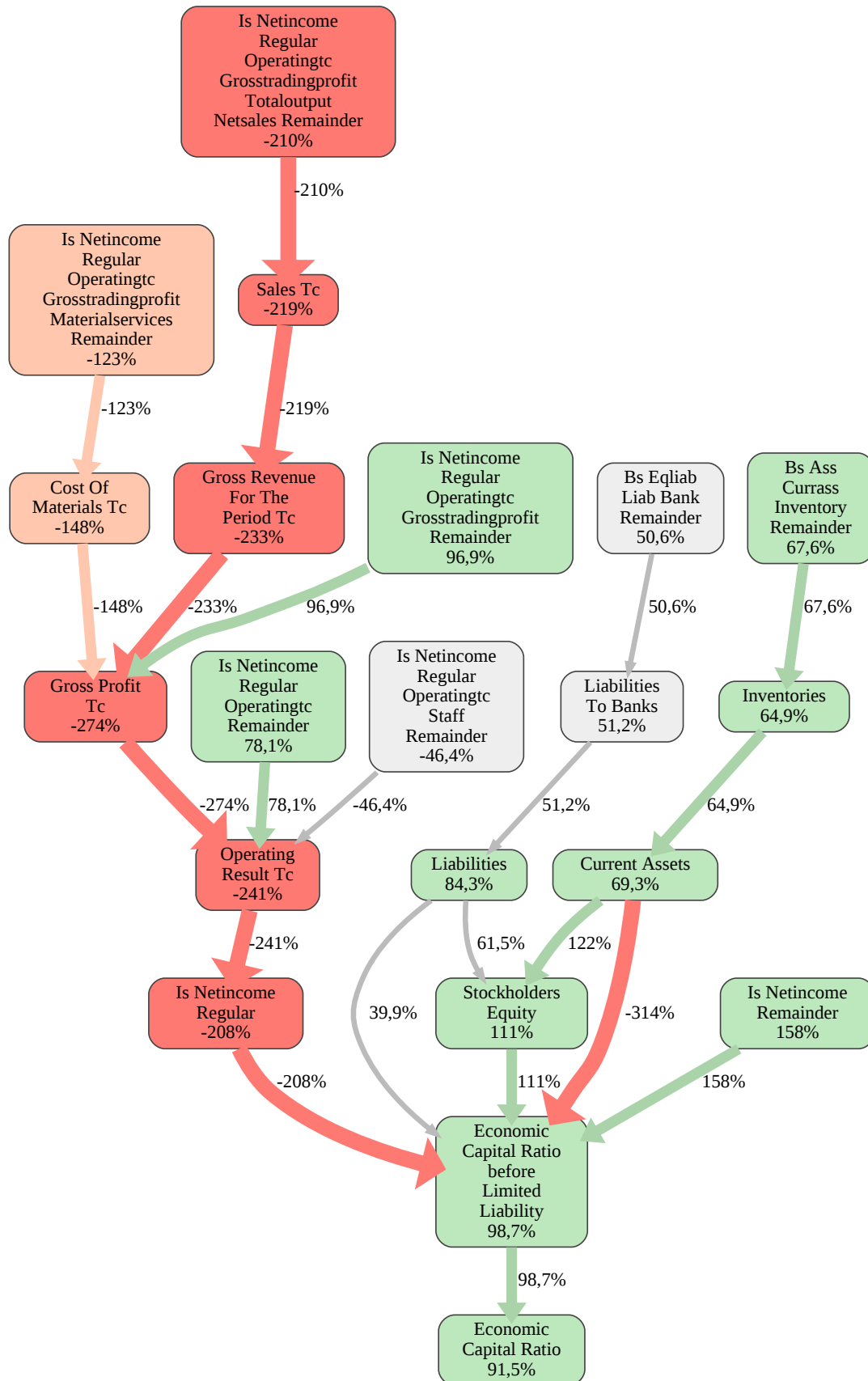




The relative strengths and weaknesses of Bremer Hamburg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bremer Hamburg GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 158% points. The greatest weakness of Bremer Hamburg GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 274% points.

The company's Economic Capital Ratio, given in the ranking table, is 189%, being 91% points above the market average of 97%.
