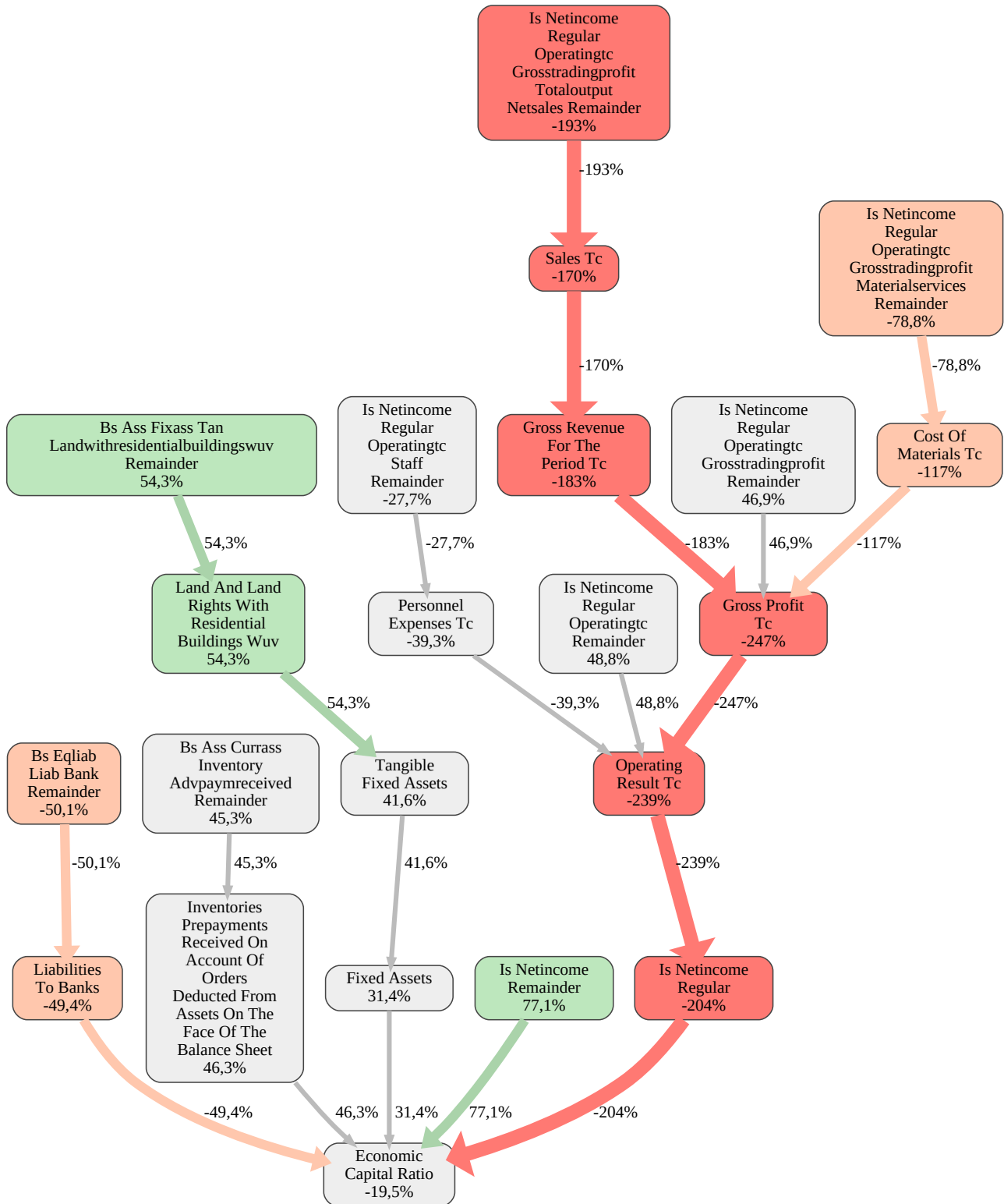

The relative strengths and weaknesses of Sewoba GmbH Seelower Wohnungsbaugesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Sewoba GmbH Seelower Wohnungsbaugesellschaft compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 77% points. The greatest weakness of Sewoba GmbH Seelower Wohnungsbaugesellschaft is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 247% points.

The company's Economic Capital Ratio, given in the ranking table, is 77%, being 20% points below the market average of 97%.
